

2. Meeting was commenced at 9:30 AM in Shelton Hotel Rawalpindi. The meeting was chaired by the Vice President NCH Homoeopathic Doctor Rao Ghulam Murtaza.

3. Homoeopathic Doctor Tabassum Hussain recited the verses from the HOLY QURAN and Homoeopathic Doctor Siddique Ali Ansari offered Naa't Sharif.

4. The Vice President informed the House that in today's meeting, the House has to dispose of the sole agenda item which is "Election of new President of NCH (in accordance with Section 4 of UAH, Act, 1965)". He further added that the election shall be held through show of hands. Thereafter, he requested the House to propose the name of Member(s) desiring to contest for the office of the President, NCH.

5. Homoeopathic Doctor Waheed Ahmed proposed the name of Homoeopathic Doctor Rao Ghulam Murtaza for President NCH. Homoeopathic Doctor Muhammad Aslam Khan and Homoeopathic Doctor Siddique Ali Ansari seconded. None of any other member came or proposed to contest the election for the office of President. Homoeopathic Doctor Rao Ghulam Murtaza, Vice President upon nomination of his name, tendered his resignation from the position of the Vice-President, which was approved by the House unanimously. He with the consent of the House, invited Homoeopathic Doctor Muhammad Irfan Wali to take the Chair and preside over rest of the proceedings.

6. Homoeopathic Doctor Muhammad Irfan Wali, accordingly, took the Chair and moved the meeting ahead.

7. Homoeopathic Doctor Mahmood ul Haq Abbasi, expressed that previous and outgoing meetings are illegal. He was of the view that Members who did not declare their assets formerly and as required vide Rule 13 of NCH (Administration and Financial Management) Rules 2008, are not entitled to cast their votes. He further objected that election of new President would be illegal before issuance of Notification for removal of out-going President, by the Federal Government. None of any member insisted for and the Chair overruled objections.

8. Homoeopathic Doctor Ilahi Bux stated that a clear division between elected and nominated members has been witnessed by nominated members since the inception of the incumbent Council. The nominated members have not been taken into confidence in finalization of nominations for the offices of the President and Vice President. He requested the Chair to make these reservations part of the record.

9. The Chair announced that as **no other** member of the Council has come up as candidate for election as President NCH, therefore, **Homoeopathic Doctor Rao Ghulam Murtaza stands as unopposed President of NCH.** Afterwards, the Chair invited Homoeopathic Doctor Rao Ghulam Murtaza for Oath-taking, and administered Oath to him as new President, NCH.

10. Homoeopathic Doctor Rao Ghulam Murtaza as the President in his initial address thanked the members for reposing confidence in him and making-over easier as President, NCH. He assured that he would work with full devotion, responsibility, loyalty and in accordance with UAH Act, 1965, and Rules/Regulations framed there-under, for promotion of Homoeopathic System of medicine. He stated that no division exists between nominated and elected members and it will be finished, if any. He will work in close coordination with the honourable members and all decisions shall be taken on merit.

11. The Chair informed the house that seat of Vice President has become vacant due to elevation of Vice President as President. He further requested the members to propose name(s) of candidate(s) for the position of Vice President, NCH. Homoeopathic Doctor Faisal Saleem proposed the name of Homoeopathic Doctor Saeed ur Rehman Khattak for candidate of Vice

President, NCH. Homoeopathic Doctor Naeem Hafeez and Homoeopathic Doctor Muhammad Idrees Tareen seconded him. No other member came up as candidate for the position of the Vice President. Hence, Homoeopathic Doctor Saeed ur Rehman Khattak was declared as unopposed Vice President, NCH. The Chair administered Oath to him as Vice President, NCH.

12. Homoeopathic Doctor Saeed ur Rehman Khattak, after taking oath thanked the House for their support in contest as Vice President, NCH. He assured that he will work honestly for up-gradation of Homoeopathic System in the light of UAH Act of 1965.

13. Homoeopathic Doctor Naeem Hafeez congratulated the newly elected President and Vice-President and desired that the members need to work together for promotion of the System.

14. Homoeopathic Doctor Mahmood ul Haq Abbasi stated that the meeting was to consider one agenda item, therefore, election of Vice President in this meeting is unlawful. Moreover, the election of President and Vice President are illegal in the present scenario. He will fight for justice and knock the doors of every single forum. He is a supporter of BHMS and enhancement of basic qualification from Matric to F.Sc. He remained President of the Council for last 10 years and worked for the System and took following steps particularly:

- i) Uniform allocation of 60 seats to all H.M. Colleges.
- ii) Enhancement of basic qualification from Matric to F.Sc,
- iii) Starting of BHMS

15. He presented himself for accountability and inquiry. He stated that he will resist and oppose all illegal activities in future. He further stated that list of enrolments for the current session must be uploaded on the NCH website after 31st January 2021. In case of non-compliance, he will knock the door of higher authorities and, or court of law. He also presented comparative financial statement of the Council's funds/reserves since he took over the charge of the Council as President NCH in 2018.

16. Homoeopathic Doctor Javed Akhter congratulated the President and Vice President, and assured for co-operation on behalf of the nominated members of the Council, in allowable, actions and decisions. He stated that nominated and elected members are supposed to vested equal status, as per UAH Act, 1965. But unfortunately the nominated members were not treated equally in the past. We are required to work together for the betterment of our profession. President and Vice President are requested to move forward for up-gradation of the System and introduce reforms in Homoeopathic Medical Colleges for improvement of standard of education.

16. Homoeopathic Doctor Muhammad Tariq Khan congratulated the President and Vice President and assured for cooperation. He advised to work for the System not for a specific group. The newly elected President and Vice President are required to complete their

commitments and should not disappoint anyone in any way. He referred to the appointment of Chairman Pharmacopoeia Committee in by-gone years and said that it was an example of incompetency. He suggested a Pharmacist as Chairman for the purpose which is available in the Council.

17. Mr. Khalil Ahmed, Chairman Finance Committee congratulated the new office bearers and appreciated the Council to conduct the whole process in a democratic way strictly in accordance with the relevant legal framework. He showed his satisfaction in this regard. He further stated that he has not seen any serious intervention by the previous Councils for popularizing or elevation of Homoeopathy System in the country. The System, instead, is waning day by day, which is alarming for survival of the System. It seems their role and efforts were personal-oriented and achieved their own political and financial goals. However, it is hoped that the newly elected President would make all-out efforts for mainstreaming the Homoeopathic System of Medicine to bring it at par with Allopathic System of medicines in terms of education, practice, research, scope and career opportunities for the homoeopathic practitioners. He also showed concerns on discrimination being meted out to the nominated members by the elected members. The nominated members, as he broadly observed during his tenure which is spanned over more than two years, are being looked down upon by the elected members. He objected that in the current election process, no prior consultation was made with the nominated members in finalizing the panel of candidates for election as President and Vice President, NCH. He said that the nominated members despite all odds cooperated with the elected members to make the process of election smooth and frictionless. Lastly, he wished success for the new team and assured them of cooperation in their actions which are in sync with UAH Act, 1965 and rules/regulations.

18. The meeting was ended with vote of thanks to and from the Chair.
