- 2. Meeting was started at 11:00 AM in Shelton Hotel Rawalpindi. The meeting was chaired by Homoeopathic Doctor Rao Ghulam Murtaza, Vice President NCH.
- 3. Homoeopathic Doctor Tabassum Hussain recited the verses from the HOLY QURAN and Homoeopathic Doctor Siddique Ali Ansari offered Naa't Sharif.
- 4. The single agenda point meeting was initiated with the précised briefing of objects of this call by the Chair and asked the Secretary to explain the legal provisions in the matter.
- 5. The Secretary / Registrar explained that the Registrar National Council for Homoeopathy received Requisition for removal of President Homoeopathic Doctor Mahmood ul Haq Abbasi on 03-12-2020, duly signed by 12 members of the Council. The Requisition has been diarized in the office at Serial No. 9020 on 03-12-2020. The Registrar accordingly read out the provisions of Regulation 16 (a) and (b) of NCH (Holding of Meetings) Regulations-1990 concluded. Accordingly the Registrar on receipt of the Notice of the motion aforesaid circulated it amongst all members of the Council vide letter dated 03-12-2020. It was incumbent and mandatory for the Registrar under Regulation 16 (b) to enter in the list of business for first working day after expiry of 07 days from the receipt of Notice under Regulation 16 (a) of NCH (Holding of Meetings) Regulations, 1990 and convene the meeting. The Registrar further explained the legal position after which the house decided to proceed in accordance with law.
- 6. The chair asked the members to rise in their seats who are in favour of the motion. 11 members stood up in favour of the motion. The chair further asked one of the member amongst signatories to move the resolution.
- 7. Homoeopathic Doctor Faisal Saleem moved and read out the resolution before the house.
- 8. The requirements of Regulation 16 were further followed and prescribed opportunity to speak was provided to person (Homeopathic Doctor Mehmood UI Haq Abbasai) against whom the resolution was tabled and the mover and others.
- 9. Homoeopathic Doctor Naeem Hafeez, Homoeopathic Doctor Javed Akhter and Homoeopathic Doctor M.B. Jawed Awan spoke on this occasion.



- 10. Homoeopathic Doctor Mahmood ul Haq Abbasi took his 30 minutes time and defended himself while maintaining and highlighting his acclaimed achievements, but admitted that he could not perform his full functions appropriately, as envisaged in UAH Act II of 1965. Others also spoke according to their moral sense. At this juncture the chair briefed the members regarding voting on the resolution by secret balloting. The chair started balloting process with the assistance of Secretary / Registrar of the Council. The members used their right of vote by marking "Tick" in specified Box with YES or NO on the ballot paper except Homoeopathic Doctor Mahmood ul Haq Abbasi who abstained to cost his vote.
- 11. After completion of this process the sorting and counting of casted votes was made in presence of out-going President Homoeopathic Doctor Mahmood ul Haq Abbasi. The result appeared after counting is as under:-
