2. Meeting started at 11:00 AM. Homoeopathic Doctor Javed Akhtar recited the verses from the "HOLY QURAN". Homoeopathic Doctor Siddique Ali Ansari offered Naa't Sharif. The meeting was chaired by President - Homoeopathic Doctor Mahmood ul Haq Abbasi. The President welcomed to all members. Mr. Imtiaz Yousaf, Deputy Secretary (Budget) Ministry of NHR&C took oath as per Regulation 3 of NCH (Holdings of Meeting) Regulations, 1990. The oath was taken by the President NCH. The President also thanked the Ministry of NHR&C on issuance of Notification of President and Vice President.

Agenda Point No. 1: To confirm Minutes of previous 148th Inaugural Meeting of NCH held on 16th November 2018.

The President presented first point of Agenda before the House. The Registrar stated that no objection letter was received from any member except Homoeopathic Doctor Ilahi Bux, which was read out before the House. At this juncture the President stated that the office has not put up to him the said objection letter, therefore the office is warned to be careful in

2. The Chairman of every committee is requested to prepare TORs/SOPs of his/her committee and submit to the office for onward submission before the Act/Rules & Regulations committee for finalization and further put-up before the next meeting for approval.

Agenda Point No. 3: To discuss Financial Position of NCH Accounts in the light of approved Budget for the current Financial Year 2018-19.

The President put next agenda before the House. Registrar was advised to brief the House about the amount allocated in each head and expenditure incurred during the tenure of Administrator. The Registrar distributed a copy of statement of Head wise approved Budget CFY 2018-19 and details of Bank balance of NCH Accounts as on 24th December 2018 before the august house. After discussion, the house approved Budget Estimate for the current Financial Year 2018-19, with some minor re-appropriation in the following heads:-

2. In addition to the above, the House further granted approval for the following:-

- a) The President, Vice President and Chairman Finance Committee was authorized to pursue the matter of TA/DA of Members of NCH equivalent to Highest Grade which was already decided by the Honourable Wafqi Mohtasib (Ombudsman)'s Secretariat Islamabad in case No. HQR-15259/15 during the year 2016 and what is the present status of appeal/presentation, if any, filed by the Ministry before the President of Pakistan.
- b) NCH should write a letter to all Homoeopathic Medical Colleges regarding outstanding claims of Superintendents and Invigilation staff against NCH, if any, within one month.
- ✓ c) Installation of Solar System in the office of NCH keeping in view of load shedding of electricity.
- ✓ d) Gas connection in the office NCH keeping in view of cold weather. OK
- ✓ e) The matter regarding Cell phone subscription for all members of the NCH on nominal raters, have to be discussed with cellular companies.
- (f) Development of new Software for computerization of NCH record. Registrar was assigned the task. He will present report in next meeting after negotiation with different agencies.

- (g) Office will contact with any nursery for plants/plantation in the office of NCH and made agreement after negotiation OR engage a Gardner on fixed wages.
- (h) Installation of CC TV Cameras in the office of NCH.
- (i) Partition in the office of NCH.
- (j) Request to the Federal Govt. for increase of Grant-in-Aid.
- (k) Honorarium to the members of NCH equivalent to highest grade as decided by the previous Council may be released in the light of decision of the Wafaqi Mohtasib, in case No. HQR/15259/15.

Meeting adjourned for launch and zuhar prayer and restarted at 2:40 p.m.

Agenda Point No. 4: To discuss matter of Regional Office Karachi and establishment of Regional Offices in other Provincial Headquarters and (i) Occupation of NCH Karachi Office Building (ii) Matter relating to Boiron HMC Karachi.

The President advised Registrar to brief the office about the background and present status of NCH Building situated Street No. 2-B/1, Block-17, Gulshan-e-Iqbal, Near Faran Club, Karachi. He briefed and stated that the building was rented out to M/s Sindh Medical Stores, Karachi by the ex-President NCH Homoeopathic Doctor Nasir Ahmad Ch, vide agreement deed dated 24-05-2005, for 10 years with a monthly rent of forty thousand first three year and 5% to 10% for next three years and 10% for last 04 years per annum. On completion of Lease agreement, the Management of National Council for Homoeopathy served Notice to Sindh Medical Stores, Karachi on 8th July 2015 for vacation of Building. Instead of vacation of building, M/s Sindh Medical Stores Karachi submitted replay of NCH Notice through Legal Advisor on 24-07-2015, wherein he requested for renewal / extension of Lease Agreement. NCH not extended the agreement and again requested to vacate the premises as the same is required for research purposes. But M/s Sindh Medical Stores Karachi filed Civil Suit No. 707/2015 in the Court of III Civil Judge East at Karachi for permanent Injunction and succeeded to get ex-party decision in his favour. The office of National Council for Homoeopathy is situated at Rawalpindi and most of notices of the Court were received after due date of hearings hence, the office could not defended the case. When it has come to the notice of NCH during the tenure of Administrator, it was decided to file an appeal before the Rent Controller Karachi. Accordingly the appeal was filed in the court of Rent Controller at Karachi which is still in progress.

2. Homoeopathic Doctor Ilahi Bux presented inspection report of Borion Homoeopathic Medical College, Karachi, which was conducted with Homoeopathic Doctor Siddique Ali Ansari, Member NCH. He stated that he observed during visit that the building which was originally rented for the Homoeopathic Institution is being used for "MULTIPLE PURPOSES OF COVERT NATURE". The report was unanimously approved by the House.

3. Homoeopathic Doctor M.B. Jawed Awan and Homoeopathic Doctor Rao Ghulam Murtaza, Vice President also took part in the discussion and stressed for vacation of the building from Sindh Medical Stores as early as possible.

4. The House further resolved as under:-

- a) Registrar will arrange a meeting with Lawyers who engaged by the Council.
- b) To stop enrollment for the session 2018-19 of Boiron HMC Karachi
- c) Write a letter to Boiron HMC Karachi to vacate building immediately.
- d) The House assigned the responsibilities to the following whose will locate & suggest suitable places in their provinces for establishment of NCH Regional Offices:-

- i) Homoeopathic Doctor Raheel Muhammad and Homoeopathic Doctor Saeed ur Rehman Khattak : KPK
- ii) Homoeopathic Doctor Waheed Ahmad & Homoeopathic Doctor M. Idrees Tareen : Balochistan
- iii) Homoeopathic Doctor M. B Jawed Awan, Homoeopathic Doctor Tabassum Hussain and Homoeopathic Doctor Aisha Nawaz : Punjab
- e) Homoeopathic Doctor Siddique Ali Ansari was deputed as Incharge of NCH Regional Office Karachi.

Agenda Point No. 5: To discuss priorities policy of NCH on yearly basis in the light of Rule-14 of NCH (Administration and Financial Management Rules, 2008.

The President put up next agenda item. He read out Rule 14 of NCH (Administration & Financial Management) Rules, 2008 *Annual Report.- A report showing performance or achievements of the Council in key areas shall be prepared annually and presented to the Federal Government*". At this stage, Registrar informed the House that an audit para has also been noted by the Audit Authorities of Federal Audit during last audit of account of NCH. After discussion the House decided that Chairman of all Committees will present their own priorities list in next meeting of the Council. The office will prepared last year report i.e. 2017-18 and put up before the Council in next meeting.

Agenda Point No. 6: To discuss and finalize Proforma/Format for declaration of Assets of NCH Members

The President put up next agenda item and invited Registrar to brief the House. He stated that a letter has issued to the Members of NCH in first inaugural meeting without prescribed Proforma as there is no Proforma is attached with Financial Rules. He further informed that as per Rule 13 of NCH (Administration & Financial) Management Rules, 2008 that after issuance of notification of Membership every member shall make a declaration of assets held by him. He also informed that an audit para has also been noted by the Audit

Authorities during last audit of accounts. With permission of the Chair he circulated a sample amongst the members of the House. **The House unanimously assigned the task to the Vice President NCH and Homoeopathic Doctor Ilahi Bux to finalize Asset Declaration Performa/Format for NCH Members.**

Agenda Point No. 7: To discuss matter regarding Homeopaths with Punjab, Sindh, KPK and Federal Health Care Commissions.

The President briefed the House about the meetings held with the CEOs of the KPK Healthcare Commission Peshawar and Sindh Healthcare Commission, Karachi. He stated that minutes of the meetings have not yet received. At this juncture Homoeopathic Doctor Ilahi Bux stated that minutes of the meeting has not yet been released by the Sindh Healthcare Commission. The Vice President and Homoeopathic Doctor Javed Akhter also took-part in the discussion and pointed out professional tax charged by Excise & Taxation Department in KPK.

Decision:

The House resolved to approach both Healthcare Commissions for issuance of Minutes of meetings. The House further resolved to write a letter to Excise & Taxation Departments for a meeting to discuss the matter relating to imposing professional tax on Homoeopathic Practitioners.

Agenda Item No. 8: To discuss policy regarding DRAP issues and its consequences.

The President presented next point of agenda and referred Section 33 of the Unani, Ayurvedic and Homoeopathic Practitioner Act, II of 1965. He stated that according to this Section NO registered or listed practitioner shall stock, use or sell any drugs or medicines except such as are included in the Unani, Ayurvedic or, as the case may be, Homoeopathic Pharmacopoeia approved by the Federal Government. He invited Homoeopathic Doctor Muhammad Tariq Khan to give presentation on DRAP to the House as he remained member of DRAP. Homoeopathic Doctor Muhammad Tariq Khan agreed with the Section 33 of the Act and informed parameters of manufacturing of Homoeopathic Medicines framed by the DRAP.

Decision:

The House showed serious concern on non-inclusion of NCH Representative in DRAP and resolved to make a request to include one Representative of NCH in each and every committee of DRAP.

Agenda Item No. 9: To discuss matter regarding amendments in UAH Act, Rules / Regulations framed there under (already submitted to the Ministry of NHR&C) in the light of Ministry of NHR&C letter No. F. 1-27/2016-Unani/Homoeo dated 31 August 2018.

The President put up next point of Agenda and read out Ministry of NHR&C letter No. F. 1-27/2016-Unani/Homoeo dated 31st August 2018 wherein both Councils were advised to prepare Unani, Ayurvedic and Homoeopathic Practitioner Act II of 1965 separately according to their own system and proposed draft forward to the Ministry. He stated that the Council has already proposed amendments in the UAH Act, 1965 and forwarded to the Ministry during the year 2012 but unfortunately the same is still pending at the part of Ministry.

Decision:

The House referred the matter to Act, Rule / Regulations Committee for preparation of separate Draft of UAH Act, 1965. The committee will complete the task before next meeting of NCH. Meeting of the committee will be summoned shortly.

Agenda Item No. 10: To discuss matter regarding training and issuance of Ultrasound Certificates.

The President put up next agenda point and advised Registrar to brief the House about the present status of the case. The Registrar briefed the background of the case which was started from the complaint of Mr. Tahir Saeed, filed before the Ombudsman for the Province of Punjab in 2013. He referred the decision of the Ombudsman's of the Punjab dated 15-04-2014 and Findings / Recommendations of the Honourable Wafaqi Mohtasib Islamabad in complaint No.HQR/0006199/17 dated 06-09-2017 and 16-11-2017. He further stated that after taking over charge by the Administrator, all correspondence issued on the subject matter were withdrawn on the directions of the Federal Government vide Ministry's letter No. F. 1-10/2017-Homoeo dated 5th June 2017. However, some persons filed cases in the Wafaqi Mohtasib Islamabad for issuance of Ultrasound Certificates after withdrawal of NCH letters on the said subject. On receipt of Findings from the Wafaqi Mohtasib in favour of complainants, NCH filed review petition before the Honourable Wafai Mohtasib which was accepted and the original Findings were recalled. The both complainants filed representations before the Honourable President of Pakistan against the recommendations of the Wafaqi Mohtasib, which were also dismissed by the President of Pakistan, with the following options:-

“The Honourable President of Pakistan has been pleased to dismiss both the representations of the complainants for the above said reasons.

Before parting with the decision, it would be expedient to note that as a result of confusion caused due to agency's permission letter dated 27-10-2016 regarding training of modern diagnostic tools and its subsequent withdrawal on 06-06-2017, a number of Homoeo Doctors had to suffer in terms of wastage of time and money in unauthorized

training without any fault of their own. The Agency may opt to seek approval of the Federal Government / Ministry of National Health Services, Regulations & Coordination under Section 47 / 48 of UAH Practitioner Act, 1965 to allow training of Homoeo Doctors in the aforesaid discipline and work out a solution to certify/accredit those who have already completed such training during the period from 27-10-2016 to 06-06-2017. Alternatively, arrangements may be made to refund the fee received from these trainees to make-up for their financial loss without further delay."

2. The office implemented alternative option "refund the fee" on the direction of ex-Administrator NCH. Last hearing of the case was held on 16-10-2018, wherein a detailed brief was handed over to the Consultant (Imp) Wafaqi Mohtasib Islamabad on his direction.

3. The President also briefed the House and requested for their view point.

4. Homoeopathic Doctor Ilahi Bux stated that this matter be not attached with DHMS Syllabus. Separate course may be started.

5. Homoeopathic Doctor M.B. Jawed Awan stated that why the Administrator withdrawn letters on the subject. He was not authorized to withdraw and proposed to re-approve the previous policy of NCH. Homoeopathic Doctor Naeem Hafeez and Homoeopathic Doctor Faisal Saleem seconded him and stressed to issue Diploma Certificates the candidates who have already completed such training. Homoeopathic Doctor Tariq Khan stated that DMRD must be engaged for such training.

Decision:

The House up-hold the decision of the previous Council and decided to release the Ultrasound Certificates to the candidates who have already completed their training as decided by the President of Pakistan in above appeal/representation and fixed Rs. 1000/- as enrolment fee, which will be charged from the students from start of session i.e. January and July every year, in future. The House also constituted a committee comprising of President and Vice President to look into the matter of SOP and should resolve in the light of direction / decision of the Implementation Cell of the Honourable Wafaqi Mohtasib. The Council further decided that the syllabus for Ultra-sonography may be put up before the Syllabus Committee and after approval by the Syllabus Committee the same may be sent to the Federal Government for inclusion of syllabus.

Agenda Item No. 11: To establish NCH Text Book Board

The President presented next agenda item and informed the necessity for establishment of NCH own Text Board. He stated that presently no proper books as mentioned in DHMS Syllabus are under-use of students or Homoeopathic Medical Colleges. A lot of substandard study material has become the part of education for the students of Homoeopathic Medical Colleges. He suggested establishing NCH own Text Board and assign task to him for publish of DHMS

Syllabus Books and some other publication. Homoeopathic Doctor Tariq Khan and Javed Akhter suggested publishing of NCH Magazine which was supported by the house.

Decision:

The House unanimously constituted Text Book Board Committee of NCH and assigned the task of printing of DHMS Syllabus Books, Code of Ethics, Pharmacopoeia, Yard Stick, NCH (Holding of Meetings) Regulations, 1988 etc. after due amendments.

Agenda Item No. 12: To discuss Enrolment policy in the light of amendment in Rule 10 of UAH System of Medicine Rules, 1980.

The President informed the House that recently the Federal Government (Ministry of NHR&C) issued some amendments in Unani, Ayurvedic and Homoeopathic System of Medicine, Rules 1980, particularly in Rule 10, which is related with the enrolment of students and academic session. According to this amendment, the Principal of every recognized institution shall send to the Council, only verified from concerned board or university education certificates of students, within a period of ninety days from the date of the beginning of the academic session starting from 1st July to 30th September year, along with a fee of five hundred rupees in form online or bank draft payable to Registrar of the respective council for each student for enrolment with that council, and where the name of a student is sent within thirty days after the expiry of that period along with additional fee of one thousand rupees as late fee charges. He also read out old Section 10 of the UAH Rules, 1980. He stated that the implementation of this amendment from current session is not possible due to academic duration adjustability.

Decision:

After heated discussion, the House unanimously resolved that enrolment of the students for the current session shall be made as per previous schedule. Rule 10 of UAH System of Medicine Rules, 1980 and Examination Regulations -1986 will be reviewed. Further verification of S.S.C. of students from concerned Boards should be verified by the Council after negotiation of verification fees etc with the Chairmen Inter Board Committee of Chairmen, Islamabad.

Agenda Item No. 13: To discuss binding of minutes of NCH meetings in shape of a Booklet on annual basis.

The President put up next agenda item and proposed that in future Minutes of NCH Meetings should be binded in shape of a Booklet on yearly basis. The House unanimously agreed with the proposal and decided to bind year-wise minutes of previous meetings from 1965 to-date.

Agenda Item No. 14: To discuss letter dated 27-11-2018 received from Homoeopathic Organization Pakistan, Lahore for permission for fund raising for construction of Homoeopathic and Research Centre.

The President read out Homoeopathic Organization of Pakistan, Star Street, Near Gourmet Bakers GT Road Shahdara Lahore-Pakistan letter dated 27-11-2018 wherein he

requested for permission for fund raising activities in all over Pakistan in connection with construction of HOP Homoeopathic Hospital and Cancer Research Centre.

Decision:

After discussion, the House constituted following committee. The committee will visit the site and submit report in next meeting:-

- a) Homoeopathic Doctor M.B. Jawed Awan
- b) Homoeopathic Doctor Aisha Nawaz
- c) Homoeopathic Doctor Tabassum Hussain
- d) Homoeopathic Doctor Naeem Hafeez

Agenda Item No. 15: To discuss Assistant Director (Homoeo.) Sindh letter dated 09-1-208 regarding expiry date of Homoeopathic Medicines / Shelf life of Homoeopathic Potencies / Medicines.

The President read out the captioned letter before the House. After some discussion, the House referred the matter to the Drug & Pharmacopoeia Committee for detail examination and report in next meeting.

Agenda Item No. 16: To discuss Recommendations Prevention Committee on Health (Sub Committee -07) – Reformation in Tibb & Homoeopathy Sector, received vide letter dated 10th October 2016.

The President read out Recommendations / Proposals finalized by the Prevention Committee on Health (Sub Committee No. 7) Reformation in Tibb & Homoeopathy Sector received through Ministry of NHSR&C vide letter dated 10th October 2016 and reminded vide letter dated 4th September 2018. He further stated that the said recommendations have already been circulated amongst the member of this august house with final agenda of the meeting. The House decided to refer the matter to Syllabus Committee for his detail examination and report in next meeting. Enrolments of students should be up-loaded on the website of NCH after preparation of new software.

Agenda Item No. 17: To discuss change of building of Faisalabad HMC for Women, Faisalabad.

The President advised Registrar to present next agenda item and briefed the House. Registrar informed the House the Principal Faisalabad Homoeopathic Medical College for Women Faisalabad vide letter dated 24-02-2018 and 20-10-2018 intimated that the management has constructed own college building as per requirement of Yard Stick. The college management has deposited prescribed fee and provided all other relevant documents of the building with request to issue NOC. The President proposed to constitute an inspection team for this purpose.

Advis

Decision:

The House constituted following inspection team who will inspect the college building:-

- a) Homoeopathic Doctor Ilahi Bux
- b) Homoeopathic Doctor M. Idrees Tareen

Agenda Item No. 18 : To discuss amendments in Code of Ethics.

The President stated that Homoeopathic Doctors are facing a lot of difficulties in advertisements, using of different titles and displaying of name plates etc in Homoeopathic Clinics, after establishment of Healthcare Commissions. He suggested some changes in the existing Code of Ethics.

Decision:

The House agreed and matter referred to the Act, Rules & Regulations Committee. The committee will detail study the existing Code of Ethics and propose suitable amendments which will be presented in next meeting

- Homoeopathic Doctor Muhammad Irfan Wali and DS (Budget) did not attend the meeting due their pre-engagements.

2. Meeting started 9:30 am under the chairmanship of Homoeopathic Doctor Mahmood ul Haq Abbas, President NCH. The Chair welcomed to all members in the meeting. Homoeopathic Doctor Waheed Ahmad recited the verses from the HOLY QURAN. Homoeopathic Doctor Siddique Ali Ansari offered Naa't sharif.

Agenda Item No. 19: To discuss letters of Homoeopathic Doctor Muhammad Irfan (Faisalabad) received through Section Officer Government of the Punjab (Specialized Healthcare & Medical Education Department, Lahore vide letter No. SO (N&AHSE)1-12/2018 dated 30th November 2018.

The President read out letters of Homoeopathic Doctor Muhammad Irfan Asghar received through Section Officer (Nursing & AHSE), Specialized Healthcare & Medical Education Department Lahore vide letter No. SO (N & AHE)1-12/2018 dated 30th November 2018 wherein requested to take necessary action on the said applications as per rules / policy under intimation to this Department. He presented his letter before the House for discussion and decision one by one as under:-

a) **Basic Criteria for admissions in Homoeopathic Medical Colleges.**

The President opened the discussion and stated that the similar nature of agenda points have been received from Homoeopathic Doctor Ilahi Bux and Homoeopathic Saeed ur Rehman Khattak, which are being clubbed with this point.

- Homoeopathic Doctor Ilahi Bux supported the proposal and stated that minimum qualification for admission in institutions of Homoeopathy is matriculations with science which is required to be replaced with Intermediate Pre-medical or F.Sc (Pre-medical).
- Homoeopathic Doctor Saeed ur Rehman Khattak referred the meetings held with D.G Health (KPK) and supported to enhance basic qualification for admission from matriculation Science to F.Sc (Pre-medical).
- Homoeopathic Doctor Waheed Ahmad stated that he is not agreed with the proposal because non-availability of F.Sc students in Balochistan province.
- Homoeopathic Doctor Siddique Ali Ansari stated that maximum Homoeopathic Teaching Institutions are in Karachi where minimum students have taken admission who has passed Intermediate with Science Group. Maximum students of Matriculations with Science are taken admission because as per Section 21 of the Act, minimum qualification is required for admission in DHMS is matriculation with Science. He further stated that subjects of Physics /Chemistry and Biology are being taught to the students regularly. In our profession passing marks are 45% instead of 33%. He was disagreed with the proposal. He proposed Matriculation with Science for DHMS and F.Sc (Pre-medical) for BHMS Degree Program.

- Homoeopathic Doctor Javed Akhter stated the World has been changed and diverted into modern era. He supported the enhancement of basic qualification for admission in DHMS from Matriculation to F.Sc (Pre-Medical) because our diploma is not accepting by the various countries like UAE, Saudi Arabia etc. On enhancement of qualification quality of education will improve and more job opportunities will be created. He supported the vision of Homoeopathic Doctor Muhammad Irfan.
- Homoeopathic Doctor Naeem Hafeez stated that students are taken admission in DHMS when they failed to take admission in Allopathy or other fields. The Federal Government has already imposed a ban on Homoeopathic Medical Colleges for construction of own building within next five years. The Council is being received maximum revenue from the Homoeopathic Medical Colleges. He opposed the proposal and agreed with the existing qualification.
- Homoeopathic Doctor M.B. Jawed Awan stated that this is an important matter. Demand for enhancement of basic qualification is coming from every side. He proposed to examine the previous enrolments for the session 20017-18, how many students F.Sc students have taken admission in DHMS. The Colleges already shifted in Day College only. No evening or second shift is allowed. Students are taken admission in homoeopathy at last. Maximum students are son or daughters of Homeopaths. Grant-in-Aid from the Federal Government has already been stopped. Maximum colleges are running in rural area. In case of enhancement of qualification revenue of the Council will be decreased, colleges working in rural area will be closed and Homoeopathy will be end. Therefore, he disagreed with the proposal and demanded data of F.Sc students enrolled during the last session.
- Homoeopathic Doctor Raheel Muhammad seconded the view point of Homoeopathic Doctor M.B. Jawed Awan.
- Homoeopathic Doctor Muhammad Asif Khan disagreed keeping in view of situation of Sindh province. He suggested to continue matriculation education for DHMS.
- Homoeopathic Doctor Tabassum Hussain supported to enhance the qualification.
- Homoeopathic Doctor Faisal Saleem proposed that letter of Homoeopathic Doctor Muhammad Irfan may be circulated in different forums. First of all, the Management of Hahnemann HMC Faisalabad took a step and stopped admission of matriculation and enrolls only F.Sc students in his college and also published an advertisement in newspapers in this regard.

- Homoeopathic Doctor Aisha Nawaz disagreed with the proposal and suggested to establish a Homoeopathic University with collaboration of Higher Education Commission.
- Homoeopathic Doctor Tariq Khan suggested qualification matriculation with Science for DHMS, F.Sc (Pre-medical) for BHMS and matriculation (Arts) subject to clearance of 03 Science subjects. He stressed to provide quality education to the students who have taken admission in DHMS and we should work for more job opportunities of Homoeopathic Doctors in the province of Punjab. We should work for their facilitation.
- Homoeopathic Doctor Rao Ghulam Murtaza, Vice President seconded Homoeopathic Doctor Tariq Khan. He further suggested to improve clinical training and required to prepare a strong policy in this regard. Quota already reserved by the Islamia University of Bahawalpur for students who have taken equivalency of first 2 years from IBCC.
- Homoeopathic Doctor Muhammad Moin Khan seconded Homoeopathic Doctor Rao Ghulam Murtaza, Vice President
- Homoeopathic Doctor Saeed Ur Rehman Khattak presented an example of India where numbers of Homocopathic Medical Colleges converted from DHMS to BHMS and again suggested to enhance qualification. He stated that if we failed to enhance the qualification, then the same will be enhanced through an Ordinance. Therefore, he requested the House for again consideration.

Decision:

The President seconded the view point of Homoeopathic Doctor Saeed ur Rehman Khattak. He referred discussion between Chairman HEC, Secretary, IBCC and Curriculum Wing and proposed to start evening shift and re-allocated seats to Homoeopathic Medical Colleges as under, subject to amendments in relevant Rules / Regulations. Further for preparation of proposal for enhancement of qualification and other amendments in Yard Stick matter referred to Act, Rules / Regulations Committee:-

b) Recommendations for Nominations of Members NCH under Section 5 (a) of UAH Act, 1965

The President read out his second letter and stated that Members of this august House were nominate by the Ministry on merit after taken interviewed. **The House appreciated the efforts of the Ministry unanimously and condemned the view point of Homoeopathic Doctor M. Irfan Asghar.**

c) Serious action to be taken against manufacturers, suppliers & sellers for bogus Homeopathic Medicines in Pakistan.

The President read out his third letter of Dr. Muhammad Irfan before the House. After some discussion, the House decided to call comments from the Pharmacies enlisted with DRAP in this regard. Further matter referred to the Drug and Pharmacopoeia Committee for examination.

Agenda Item No. 20: To discuss application of Mr. M. Faisal regarding issuance of final transcript of all 4 years marks sheets.

The President read out request received from Mr. Faisal Mughal regarding issuance one transcript of all four years marks sheets of DHMS and restart of equivalency of B.Sc (Homoeo) by Federal Urdu University, Karachi. Homoeopathic Doctor Ilahi Bux supported the view pot of the mover.

Decision:

After discussion the House unanimously granted approval for the following:-

- a) Issuance of transcripts separately for first 2 Years and final transcript after fourth year- 1st to 4th Year basis.
- b) Reminder to the Federal Urdu University for restarting of B.Sc. equivalency certificate to the applicants. Homoeopathic Doctor Siddique Ali Ansari was assigned the task to contact with the concerned person of the University.
- c) In future all documents i.e. Diploma and mark sheets should be printed from Security Printing Corporation of Pakistan Press, Karachi/ Islamabad with security bar/code.

Agenda Item No. 21: To discuss matter regarding de-recognition of Al-Falah Homoeopathic Medical College, Toba Tek Singh.

The President presented next agenda item before the House and Registrar was invited to brief the House. The Registrar informed the House that on a compliant of Akhtar Abbas S/o Abdur Rashid resident of Roshan Park, Kanal Road, Toba Tek Singh, the Deputy Commissioner Toba Tek Singh constituted Inspection Team comprising of Chief Executive Office, DHA, DEA, District Health Officer (PS) DHA and Director DHDC Toba Tek Singh. The team inspected the

college on 17-07-2018. The report of the tem was received through covering letter of the Deputy Commissioner Toba Tek Singh on 02-10-2018, wherein the college was declared sub-standard and NCH was requested to look into the matter and take necessary action as per law/policy under intimation to this office. The matter was placed before the then Administrator. The Administrator approved the case of Al-Falah HMC Toba Tek Singh for de-recognition but he proposed to re-inspection the institution before submission to the Federal Government for de-recognition. However, the case is still pending in the office.

2. The President proposed to constitute an inspection team who will re-inspect the college. The House agreed with the proposal and constituted an inspection tem comprising of Homoeopathic Doctor Naeem Hafeez and Homoeopathic Doctor Tabassum Hussain, Member NCH. The team will inspect the college and submit his report with 15 days.

Agenda Item No. 22: To discuss matter regarding dispute of Bahawalpur Homoeopathic Medical College, Bahawalpur.

The President put up next agenda and invited the Vice President to brief the House. Te Vice President briefed the back-ground of the case and stated that basically a dispute between the society of the BHMC. The members of the society are divided in two groups by the ratio of 3-4. Rent Agreement of the building is expired. Presently 03 members of the society occupied the building. Two Principals are working. Account of the college is sealed and persons working the college are facing lot of difficulties due to nonpayment of their salaries. He suggested to probing the matter of BHMC Bahawalpur through an inquiry committee and also considers appointment of Administrator in the college to run day to day affairs. Homoeopathic Doctor Saeed ur Rehman Khattak, Homoeopathic Doctor Ilahi Bux and Homoeopathic Doctor Muhammad Asif Khan took-part in the discussion and seconded to the Vice President.

Decision:

The House unanimously constituted following committee to probe the matter and report in the next meeting of the Council:-

- i) Homoeopathic Dr. M.B. Jawed Awan
- ii) Homoeopathic Dr. Ilahi Bux
- iii) Homoeopathic Dr. Saeed ur Rehman Khattak

Agenda Item No. 23: To discuss electricity matter (extension of load) of NCH Office building.

The President put up next agenda item and directed Registrar to brief. Registrar stated that a Notice regarding illegal extension of electricity load has been received from the Islamabad Electricity Supply Company Ltd Office of SDO (E) Gangal Sub Division IESCO Rawalpindi wherein he pointed out that according to their record NCH sanctioned load was 5 KW but illegally extended / connected 9 KW load. SDO directed NCH to apply for extension of load otherwise authority is entitled to disconnect you electricity connection without further information. On the receipt of Notice, officials of NCH visited the office of SDO on 17-09-2018.

During meeting with SDO (E), he suggested to install your own transformer of 50 KW immediately. After installation of separate transformer of 50 KW, 50% monthly electricity bill of NCH will be reduced. Therefore, approval of the following amount is required :-

Agenda Item No. 24: To discuss amendments in MoU between NCH and Al-Hamd University, Quetta (Balochistan).

The President briefed the House regarding meeting with the Management of Al-Hamd Islamic University Quetta/Islamabad on the MoU already signed between NCH & University. He stated that now the University has proposed some amendments in the existing MoU. He suggested to authorize the President to examine/sign on behalf of the Council after complete scrutiny. **The House approved amended MoU and authorized President NCH to sign on behalf of the Council with President Al-Hamd Islamic University Quetta/Islamabad and to take necessary steps for further implementation. The House up-hold the decision taken by the previous Council in its 147th Regular Meeting, which was held on 28-29 March 2017 for recognition of Al-Hamd Islamic University Quetta/Islamabad and advised to forward the case to Ministry for recognition under section 9-A of UAH System of Medicine Rules, 1980.**

Agenda Item No. 25: To discuss advertisement policy (Print, Social & Electronic) Media & Lecture programs.

The President referred the advertisements and lecture programs being uploaded from different persons in the Social media, print & electronic media which creating a bad image of the profession. He stated that Homoeopathic Practitioners are advising medicines to the patients on the social media. He suggested preparing a policy to stop these unethical activities and only allowed them in the light of parameters as fixed in the Code of Ethics.

2. The Vice President stated that this practice is against the Code of Ethic and proposed to refer the matter to Advertising Committee.
3. Homoeopathic Doctor Tariq Khan stated that it is the right of this august house to regulate these things.

Decision:

The House referred the matter to Advertising Committee for formulating of comprehensive policy which will be put up in next meeting of the Council.

Amir

Agenda Item No. 26: To discuss allocation of seats to Homoeopathic Medical Colleges.

Already discussed and decided at Point No. 19. However, the House unanimously agreed to re-allocate 60 seats to all Homoeopathic Medical Colleges from the next session till amendment in Yard Stick.

Agenda Item No. 27: To discuss DHMS Annual Examinations & March Test.

The President briefed the House about existing system of DHMS Examinations and suggested to conduct March Test of students as required vide Regulation 21 (2) of the Homoeopathic Examination Regulations, 1986 under the supervision of NCH.

2. Homoeopathic Doctor Saeed ur Rehman Khattak proposed to take examination in Semester system instead of Annual. Homoeopathic Doctor Ilahi Bux supported him.

3. Homeopathic Doctor M.B. Jawed Awan supported the proposal of March Test under the supervision of NCH.

Decision:

After detailed discussion the House resolved that in further March Test as required vide Regulation 21 (2) of student's shall be held under the supervision of NCH. The Council shall prepare objective type question papers and also appoint Inspectors to check the attendance / transparency during the course of test.

Agenda Item No. 28: To discuss printing of Registration/Renewal Certificates, Mark Sheets etc. and change of their specimens.

The President presented next point of agenda and briefed the House about the existing pattern of Registration and Renewal Certificates. He stated that a number of complaints have been received about the poor quality of certificates. Shape of certificates damaged during dispatch. Printing of certificates is required to be secured and printing quality is required to be improved by purchase a colour printer.

2. The Vice President stated that a copy of code of ethics must be provided to every practitioner at the time of registration. Homoeopathic Doctor Faisal Saleem, Homoeopathic Doctor Javed Akhter and Homoeopathic Doctor Ilahi Bux showed their concerns about verification of SSC of practitioners for registration and renewals.

Decision:

The House resolved that:-

- a) A copy of Code of Ethics must be provided to fresh registered practitioner's alongwith Registration Certificate, after publication.
- b) Matter regarding change of specimen of Registration and Renewal Certificates referred to Registration & Renewal Committee.

Ilahi

- c) Verification of S.S.C. from concerned Boards has been discontinued except students who have enrolled in session 2003-04 and onwards. Responsibility of verification of SSC will be upon NCH and fee will be fixed after confirmation from Boards. However, in case of any doubt on any SSC, Registrar is allowed to verify the same from the Board concerned.

Agenda Item No. 29: To discuss application of Homoeopathic Doctor Zahid Iqbal Adil regarding inspection of his clinic by PHC and raised objections.

The President put up next agenda item and read out request of Homoeopathic Doctor Zahid Iqbal Adil, resident of Mamo Kanjan (Faisalabad) regarding permission for admission of addicted patients in his clinic because the Punjab Healthcare Commission stopped indoor services of addicted patients until permission of this Council. He also provided a copy of letter of PHC with his application.

Decision:

The House granted approval for indoor treatment of addicted patients to the applicant in the light of Section 33 of UAH Act, 1965.

Agenda Item No. 30: To discuss letter dated 17-12-2018 of H/Dr. Muhammad Rafaqat Ch, Chairman Examination Committee, NCH (A.J.K.) and request of H/Dr. Farooq Khan for registration of Homoeopathic Doctors with NCH Pakistan.

The President presented next agenda item and read out Homoeopathic Doctor Muhammad Rafaqat Ch, Chairman Examining Committee NCH (AJK) letter dated 17-12-2019 wherein he requested for registration of persons qualified from AJK Council with NCH Pakistan. The President also referred the Rule 4 (1-A) of UAH System of Medicines Rules-1980. After discussion, the house constituted following committee to examine the matter and report in next meeting of the Council:-

- i) H/Dr. Rao Ghulam Murtaza, Vice President NCH
- ii) H/Dr M.B. Jawed Awan, Member NCH
- iii) H/Dr. Muhammad Asif Khan
- iv) H/Dr. Javed Akhter, Member NCH

Agenda Item No. 31 : To discuss application of H/Dr. Muhammad Qurban, Muhammad Naeem Akhtar, Muhammad Sohail dated 18-12-2018 regarding use of diagnostic tool in Homoeopathic Clinic.

The President put up next agenda item and red out application submitted by Homoeopathic Doctor Muhammad Qurban, Homoeopathic Doctor Muhammad Naeem Akhtar and Homoeopathic Doctor Muhammad Sohail regarding detail of diagnostic tools which will be used by a Registered Homoeopathic Practitioner in his clinic. Registrar informed that a letter has already been circulated amongst Chief Operating Officers of Punjab & Sindh Healthcare Commission as well as all DHOs of both provinces in April 2018. **The House resolved that the**

office should again circulate list of diagnostic tools authorized to Homoeopathic Practitioners to all three Healthcare Commissions.

Agenda Item No. 32: To discuss authorization of staff car.

The Vice President put up next agenda point and informed background regarding purchase of car. He stated that basically NCH purchased Toyota Corolla Car 1300 CC Registered No. UF-188 which was took over by the Ministry and further monetized by Mr. Faridullah Khan ex-Secretary, Ministry of NHR&C. After long correspondence with the Ministry, the vehicle Registered No. GU-644 has been received as replacement of UF-188 on 18-04-2018. The said vehicle is being used by the President National Council for Homoeopathy for official purposes only. He requested the house to grant authorization to the President NCH.

Decision:

The House unanimously authorized the President NCH to use car subject to the following conditions:-

- a) Only ~~360~~ 360 liters petrol per month allocated.
- b) Log Book must be maintained regularly.
- c) In case of use of vehicle out station (official purposes) payment will be made on production of original receipts of petrol and toll plaza receipt etc.
- d) Any member of the Council may use the vehicle for official business with approval of Authority.

Agenda Item No. 33: To discuss meeting with Secretary Inter Board Committee of Chairmen (IBCC) held on 13th December 2018.

The President presented next agenda item and briefed the House about the meeting held with IBCC Secretary on 13-12-2018 on the issue of equivalence of first 2 years, removal of condition on the equivalence certificate and inclusion of Chairman Examining Body in the list of Chairmen's. He stated that minutes of the said meeting has been received today. Registrar was asked to distribute these minutes amongst the members of this august house for information. He further stated that after finalization of MoU with Al-Haamd Islamic University Quetta/Islamabad students will also take admission for clearance of 03 additional subjects of HSSC level. After study of minutes, the house appreciated the efforts of President NCH.

Agenda Item No. 34: To discuss pending decision of the previous Council regarding recognition of colleges / other.

The President referred the decision taken by the previous Council about recognition of newly established Homoeopathic Medical Colleges and advised Registrar to brief the House. The Registrar presented a list of 10 pending newly established Homoeopathic Medical Colleges and informed present status of each college. The House, after discussion, referred the case to Chairman Inspection Committee for re-inspection.

Decided

Agenda Item No. 35: To discuss matter relating to recognition of Mianwali HMC Mianwali.

The President put up next point of agenda and stated that case of newly established Mianwali HMC Mianwali was received in the office of NCH on 04-10-2016. On receipt of application an inspection team was constituted. The team inspected the college and pointed out some deficiencies in the college building. Now the Principal informed that he has removed these deficiencies and requested for fresh inspection. After some discussion, the House unanimously constituted an inspection team comprising Homoeopathic Doctor Javed Akhter and Homoeopathic Doctor Muhammad Tariq Khan for inspection and report before next meeting.

Agenda Item No. 36 : To discuss matter relating to direct correspondence with higher authorities in the light of Ministry's letter.

The President referred earlier letter issued by the defunct Ministry of Health wherein Ministry directed to the members of NCH and Principal of HM Colleges not to made direct correspondence directly with the Ministry. All correspondence with the Ministry must be routed through National Council for Homoeopathy. The same has already been circulated by the Council. The House decided to again circulate Ministry's letter amongst members of the Council as well as Principals of H.M. Colleges and Homoeopathic Magazines for information of Homoeopaths all over the country.

Agenda Item No. 37 : To discuss Principal German Homoeopathic Medical College letter No. 001 dated 15-12-2018 regarding admission of Science students.

The Vice President put up next agenda item and read out letter No. 001 dated 15-12-2018 of Principal German Homoeopathic Medical College, Lahore, wherein he referred Section 21 (2) of the Act and requested to allow admission to the students who have passed matriculation with Computer Science subject. He also read out Section 21 (2) of the UAH Act, 1965 and proposed that subject of Biology to be passed by the students whose desire to obtain equivalency of first 2 years from IBCC. However, students who have passed their matriculation with computer science subject are eligible for admission in DHMS.

Decision:

After discussion the House decided as under with vote of descent of the President NCH and Homoeopathic Doctor Saeed ur Khattak:-

- a) Passing of subject of Biology is compulsory for those students who desire to obtain Equivalency of first 2 years from the IBCC.
- b) Students who have passed matriculation with Science Group are allowed to take admission in DHMS in the light of Section 21 (2) of UAH Act, 1965.
- c) Students must be informed before admission that he/she will not be entitled for equivalency of 1st 2 Years unless clearance of the subject of Biology. Affidavit must be obtained from the student in this regard.

Agenda Item No. 38: To discuss application filed by Homoeopathic Doctor Sadam Hussain regarding treatment of different diseases.

The Vice President put up next agenda point and read out application dated 10-12-2018 of Homoeopathic Doctor Sadam Hussain (Okara) regarding clarification of Homoeopathic treatment of different diseases. The House discussed his application and clarified that a registered Homoeopathic Doctor may treat the following diseases and use the instruments like Thermometer, Blood Pressure apparatus and Stethoscope in his clinic.

- i) Drugs Abuse.
- ii) Psychological Disorder.
- iii) Minor Surgery with Homoeopathic Medicines.
- iv) Registered practitioner may use the Thermometer, Blood Pressure apparatus and Stethoscope, Gluco meter for ready reference etc. and all other instruments / apparatus for taking sign for proper treatment of the patient.

Agenda Item No. 39 : To discuss application dated 20th December 2018 filed by Homoeopathic Doctor Malik Mehboob Ahmad Khokhar regarding use of Magneto-therapy.

The President put up next agenda item and read out application submitted by H/Dr. Azhar Naveed Somroo, H/Dr. Rana Tariq Mehmood and H/Dr. Zahid Hussain Mirza, resident of Lodhran regarding use of Magneto therapy by Homoeopaths for Palliative and Supportive purposes. After discussion the house decided that the matter will be decided after proper visit of clinic / hospital established at Bahawalpur. The same team will visit the clinic/hospital which has been constituted for visit of Bahawalpur HMC Bahawalpur.

2. Meeting started 10:00 am under the chairmanship of Homoeopathic Doctor Mahmood ul Haq Abbas, President NCH. The Chair welcomed to all members in the meeting. Homoeopathic Doctor Muhammad Aslam Khan recited the verses from the HOLY QURAN. Homoeopathic Doctor Siddique Ali Ansari offered Naa't sharif.

3. Before start of agenda points of the members, the President presented Minutes of the Meetings of Finance Committee, detail of expenditure incurred during the tenure of Administrator and progress report of the office working for the period from 20th November 2018 to 24th December 2018 before the House as under:-

3. The Vice President demanded the membership card from the office and suggested to improve its quality. Registrar assured that cards will be prepared shortly.

4. Homoeopathic Doctor Saeed ur Rehman Khattak, Homoeopathic Doctor Muhammad Asif Khan, Homoeopathic Doctor M.B. Jawed Awan, Homoeopathic Doctor Ilahi Bux, Homoeopathic Doctor Muhammad Tariq Khan took part in the discussion and showed serious concerns about the quality of Dr. card, non-issuance and late delivery. They proposed to improve quality, adoption of fast communication system, preparation of cards in the office by purchasing own machine or colour printer etc. and dispatch of Doctor cards with Registration / Renewal Certificates. Homoeopathic Doctor Ilahi Bux stated that distribution of Registration/Renewal and cards etc through different venders is not appreciate able because they do not hand over to the concerned persons. Facilitators are required to inform to the concerned person on telephone to collect the document. He questioned about receiving of any urgent fee in One Window Operation. Non-receipt of urgent fee is a loss of fund of NCH.

5. The President stated that a Complaint Cell has already established in the office and as yet complaints of 100 of complainants have been redressed. System will be computerized by installation of new software. CCTV Cameras are by installed in the office of NCH for monitoring the working of staff. Near future One Window operation is being started in the office for issuance of registration, renewal, diploma certificates and marks sheets in the same day. No extra fee will be charged from them as not mentioned in our Rules / Regulations. He also read out the Balance Sheet of NCH Accounts existing and previous when the charge was handed over to the Administrator.

6. Homoeopathic Doctor Saeed ur Rehman Khattak stated that misuse of funds of NCH during the tenure of Administrator. He proposed that account of NCH may be audited. At this juncture, with permission of the chair, Registrar stated that No money has been misused, detail of payments (head-wise) will be provided as and when required by the House.

Decision:

After long discussion, the House approved the Minutes of the Finance Committee meeting held today's morning, appreciated the efforts of the President, taken in a short time and further decided as under:-

- i) By hand registration / renewal, diploma certificates, and marks sheets will only be delivered to those persons who would be in possession of Authority letter.
- ii) All Homoeopathic Medical Colleges and Members of NCH are only authorized to collect the cases of registration/renewals at his / her camp offices from the public.
- iii) Machine may purchased/installed in the office of NCH for preparation of Drs. Cards.
- iv) Registration / Renewal Certificates will be dispatched with Dr. card.
- v) NCH will issue letter of Camp offices of Member's NCH.
- vi) One Window Operation may be started immediately.
- vii) Accountant is only authorized to deposit Demand Drafts in the Bank.

For re-proving the remedies under scientific protocols mentioned above, we need a standard protocol, highly educated professionals in the relevant field and funds.

Homoeopathic Doctor Muhammad Asif Khan stated to contact with DRAP for fund on account of NCH share of Homoeopathic Pharmacies /companies enlisted with DRAP.

Decision:

The House decided as under:-

a) As building of NCH is available at Karachi, therefore, first Research Centre will be established in the same building. Efforts will be taken to obtain space in NIH.

HOMOEOPATHIC DOCTOR SAEED UR REHMAN KHATTAK

Point No. 1: Working of the Council (Ethic Committee)

Homoeopathic Doctor Saeed ur Rehman Khattak briefed the house on his point and suggested to constitute an Ethic Committee for smooth working of the Council. The House resolved that Steering Committee has already been constituted under the Chairmanship of Homoeopathic Doctor M. B. Jawed Awan. In presence of Steering Committee, no need of constitution of other any committee.

Point No. 2: Re-organization of Homoeopathic Institution Forum in KPK

Homoeopathic Doctor Saeed ur Rehman Khattak briefed on his point and stated that Homoeopathic Institutions of KPK are divided into at least 3 zones and proposed to re-organize like a) KPK & Rawalpindi Division b) Punjab and c) Sindh. The House disagreed with the proposal and decided that a meeting of Homoeopathic Medical Colleges of KPK will be scheduled for their unity but constitution of forum at Council level is not possible. However, the mover withdrawn his point.

Point No. 3: Syllabus up-gradation

Homoeopathic Doctor Saeed ur Rehman Khattak suggested the following changes in the existing DHMS Syllabus:-

- a) Text Reference books must be updated and may be revised according to the standard.
- b) Gynecology/Obstetrics syllabus is very much short as less as one year(academic) is concern.
- c) Materia Medica and Pharmacy are the fundamentals and basic subjects of Homoeopathic system so these may be included right from 1st year of DHMS.
- d) Syllabus of Microbiology is again very short for one academic year, it may elaborate more.
- e) Microbiology may adopt as a minor part of Pathology subject.
- f) Community medicine may also include in 2nd year of DHMS, as it is very light weighted subject and may not be included in senior classes like 3rd year and 4th year of DHMS.
- g) Psychology is a taught and dry subject so it may be in 3rd and 4th year of DHMS.
- h) Practical/viva should be based on short questions/Fill in the blanks, in order to prevent any explanation to the students.
- i) The scheme of studies for general subjects may be as follow:-
 - i) Islamiyat - First year of DHMS
 - ii) Pak Studies - Second -do-

2. After discussion, the House referred the matter to the Syllabus Committee for consideration.

Point No. 4 : Observational Studies in Government Hospitals

Homoeopathic Doctor Saeed ur Rehman Khattak raised the following points before the House:-

- a) The curriculum of modern medicines and Homoeopathy is about to same.
- b) The difference exists in the Pharmacology, the Philosophy and Materia Medica.
- c) Therefore, in the clinical practice there is no difference in case taking.
- d) The Homoeopathic students are mainly concerned with taking the history and understanding the symptoms of the patients.
- e) Punjab Government through notification No. 40-987-1130-Homoeo dated 14-06-2013 permitted one year house job in Government hospitals at District and Tehsil levels for BHMS students.

2. After discussion, the House referred the matter to the Syllabus Committee for consideration.

Point No. 5: DHMS Shifted to FSs pre-medical and the duration may reduce to 3 years.

The point has already been discussed and decided at point No. 19 (a).

Point No. 6: Teacher Refresher Course

The point has already been discussed and decided at Point No. 4-Members Identical Points.

Point No. 7: Presentation on Development of an integrated software system

The point has already been discussed and decided at Point No. 3 at page 9.

Point No. 8 : Copping during Examination

Homoeopathic Doctor Saeed ur Rehman Khattak referred the cases of copying during DHMS examinations and proposed to introduce objective type question papers for Viva Voce due to shortage of time. Homeopathic Doctor Ilahi Bux stated that cheating cannot be stopped. Homoeopathic Doctor Faisal Saleem disagreed with the proposal and stated that the matter is his own college.

Decision:

The House resolved that as the March Test will be conducted under the supervision of NCH. Objective type Question papers will be prepared by the Council and steps shall be taken to stop cheating/copping. However, the matter referred to the Examining Body for planning a strategy to stop cheating for larger interest.

Point No. 9: Increase of Annul Budget

Homoeopathic Doctor Saeed ur Rehman Khattak suggested that NCH may approach to the Federal Government for increase of Annual Grant-in-aid as the existing grant is insufficient. **The House agreed with the proposal.**

Point No. 10: Holding of International Conference

Homoeopathic Doctor Saeed ur Rehman Khattak proposed to hold an International Conference by NCH. **The President informed that the matter is in process and concerned quarter will be requested shortly.**

Point No 11: Shifting of Homoeopathic Medical Colleges to BHMS at-least one third college in these five years to different Universities.

Homeopathic Doctor Saeed ur Rehman Khattak proposed that efforts may be made to shift one third Homoeopathic Medical Colleges to BHMS Degree Progrm in these five years. **The House resolved that a letter sent to all Homoeopathic Medical Colleges to contact with the nearest university for affiliation for BHMS Degree program.**

HOMEEOPTIC DOCTOR ILAHI BUX

Point No. 1: Appointment of a working committee to prepare the proposal and feasibility for establishment a National Homoeopathic University on basis of public private partnership(PPP), initially in Karachi as a building of NCH is already available in Karachi (The said university is to be chartered federally).

Homoeopathic Doctor Ilahi Bux requested the House to appoint a working committee to prepare the proposal and feasibility for establishment of Homeopathic University on the basis of public and private partnership, initially in Karachi as building of NCH is already available in Karachi. The President stated that working for establishment of Homoeopathic University is in process. SMB University offered land and collaboration of NCH for jointly establishment of university but their working found unsatisfactory. We are trying to allocate land in NIH Islamabad. Second option is available for university in NCH building at Karachi. He proposed to contact with SMB University for establishment of Homoeopathic University with collaboration of NCH. **After discussion the House unanimously constituted following committee who will prepare feasibility report for establishment of Homoeopathic University:-**

- i) Homoeopathic Doctor Ilahi Bux
- ii) Homoeopathic Doctor Saeed ur Rehman Khattak
- iii) Homoeopathic Doctor Tariq Khan
- iv) Homoeopathic Doctor M.B. Jawed Awan

Review

Point No. 2: Amendments in the Section 21 (2) of UAH Act, 1965, replacing the minimum qualification for admission in institutions of homoeopathy "Intermediate Pre-medical or F.Sc. Pre-medical instead of "Matriculation with Science). The subsequent changes may also be suggested in Section 20 and relevant rules and regulation accordingly. (This attempt will pave a safe way to upgrade the whole of the homoeopathic educational structure).

The point has already been discussed and decided at point No. 19 (a).

Point No. 3: To improve the quality of education and keeping an unblemished List of Teachers, formulating of Regulations for Teaching Faculty / Staff in all type of Homoeopathic institutions are utmost necessary. Necessary steps to be taken accordingly.

Homoeopathic Doctor Ilahi Bux stated that to improve the quality of education prepare an unblemished List of Teachers because it has been noted in the recent election that Teachers Lists were consisting on one family which were found unsatisfactory. He further proposed to formulate Regulations for Teaching Faculty / Staff as presently no Teaching Regulations of NCH is available. After discussion the matter referred to the Act, Rules/ Regulations Committee for preparation of Draft of Teaching Regulations and other proposals.

Point No. 4: Appointment of a new committee viz. Capital and Provincial Health Care Commissions Committee under section 14 (cc) of UAH Act, 1965 (It is need of the time to provide better input for achieving the goals of Healthcare commissions of the Capital and provinces).

The point has already been discussed and decided at Point No. 2.

HOMEOPATHIC DOCTOR MUHAMMAD IDREES TAREEN

Point No. 1: Computerization of all departments of NCH.

The point has already been discussed and decided at Point No. 3.

Point No. 2: Issuance of Marks Sheet to H.M. Colleges immediately after declaration of Result. (Within a week).

Homoeopathic Doctor Muhammad Idrees Tareen proposed that NCH is required to issue result of both students (Fail/Pass) in the gazette so that student may aware about his/her subjects in which he/she passed or failed. Marks Sheets of the students must be released immediately after declaration of result. Result of RW students must be entered in the gazette. The House agreed with his proposals and directed to the Controller of Examinations to implement from next examination.

Point No. 3: Establishment of Sub-Registrar offices in all four provinces.

The point has already been discussed and decided during budget discussion.

Point No. 4: Restoration of Hajj quota of Homoeopathic Doctors.

The point has already been discussed and decided at point No 3-Members Identical points.

Point No. 5: Payment of Remuneration Bills of Superintendents and Colleges.

The point has already been discussed and decided at point No. 3.

HOMOEOPATHIC DOCTOR WAHEED AHMAD**Point No. 1: Restoration of Hajj quota of Homoeopathic Doctors.**

The point has already been discussed and decided at point No. 3-members (Identical) points.

Point No. 2: To exempt Registration and Renewal Certificates for casting of vote in NCH election and to provide facility to present only Homoeopathic Doctor Card at the time casting vote.

Matter referred to the Act, Rules/ Regulations Committee.

Point No. 3: To provide facility to Homoeopathic Doctors to apply on line for Registration / Renewal and certificate may be issued within a week. In case of any objection send to the applicant through email or informed telephonically.

The point has already been discussed and decided at point no. 30.

Point No. 4: To restart one window operation.

The point has been discussed and decided at point no. 30.

Point No. 5: To issue guide lines to the Assistant Directors of Provinces.

The point was discussed decided as under:-

- a) A meeting with the Assistant Director Punjab, Sindh and K.P.K. may be scheduled in the office of NCH after coordination with them to discuss the matter relating to Homeopathy.
- b) A letter may be sent to the DG (Health) Sindh for a meeting to discuss matter regarding establishment of Homoeopathic Dispensaries and appointment of Homoeopathic Doctors in the province of Sindh.

Revised

Point No. 6: Establishment of Modern Library in the office of NCH.

The House agreed with the proposal of establishment of Modern Library in the office of NCH.

HOMOEOPATHIC DOCTOR FAISAL SALEEM

Point No. 1: Establishment of NCH own Text Board for printing of syllabus and magazine.

The point has already been discussed and decided at point no. 11.

Point No. 2: Establishment of Homoeopathic Research Centre in University of Faisalabad.

The point has already discussed and decided at point no 6-Members (Identical) points.

Point No. 3: BHMS Graded Degree/5 Years start up from GC University Faisalabad, University of Agriculture, Faisalabad & Minhaj University, Lahore.

The mover - Homoeopathic Doctor Faisal Saleem suggested to forward a written request to the Universities i.e. G.C. University Faisalabad, University of Agriculture and Minhaj University Faisalabad to start BHMS 5 Years Degree Program. At this stage the President questioned with Homoeopathic Doctor Saeed ur Rehman Khattak about the legal position of 2 Years BHMS Graded Degree Program in the eyes of Higher Education Commission. Homoeopathic Doctor Saeed ur Rehman Khattak explained the House that 2 years program was not approved by HEC, only 03 Years Degree Program after passing DHMS 4 Years Diploma is legal and approved from the HEC. The President stated that it has been noted that some Homoeopathic Medical Colleges are running 2 Year BHMS Degree Program, which is not as per the prescribed criteria of HEC and syllabus is also one year short. He proposed that matter regarding preparation of one year syllabus may be referred to the syllabus committee accordingly and issue instructions to concerned H.M. Colleges to stop 2 years Degree Program immediately. **After discussion the house resolved as under:-**

- a) Matter regarding preparation of one year syllabus was referred to the Syllabus Committee in the best interest of students
- b) Issue a letter to concerned H.M. Colleges to stop 2 Year BHMS Degree Program immediately in the best interest of profession and to save the future of students.
- c) F.Sc. (Homoeopathy Group) or having equivalent qualification are allowed to get admission in BHMS 5 Years Degree Program with F.Sc pre-medical group.
- d) DHMS passed students granted exemption of 2 years or 4 semesters of BHMS already approved by HEC with the substitution of subjects i.e. Pharmacy (Part-I) of Semester V and Pharmacy (Part-II) of Semester VI, Anatomy (Part-I & II) and Physiology (Part I & II) will be replaced.

Resin

Point No. 4: Re-consider policy for Homoeopathic Doctors facing problem regarding matric verification from Boards relating to delay of registration / renewal certificate its affect.

The point has already been discussed and decided at point no 28.

HOMOEOPATHIC DOCTOR JAVED AKHTER

Point No. 1: Enhancement of Standard of Homoeopathic Education

The point has already been discussed and decided at point No. 19 (a).

Point No. 2: BHMS Degree Programs should be launched.

The point has already been discussed and decided at point 19 (a).

Point No. 3: Equivalent of DHMS Diploma upto BSc

The point has already been discussed and decided at point no 20.

Point No. 4: Syllabus of DHMS/ BHMS.

The point has already been discussed and decided at point no 16.

Point No. 5: Transfer of Examination System.

The point has already been discussed and decided at point 27.

Point No. 6: Professional Development & Training Program.

The committee at Serial No. 10 under Point No. 2 namely "Professional Development Program" has already been constituted.

Point No. 7: NCH Affairs / Management.

The point has already been discussed and decided at point no. 1 of H/Dr. Saeed ur Rehman Khattak.

Point No. 8: Hajj Medical Mission and Foreign Visit.

The point has already been discussed and decided at point no 3-Members Identical points.

Point No. 9: Province Healthcare Commission.

The point has already been discussed and decided at point no 7.

Point No. 10: Preparation of Separate Voters List.

The House decided that there is no provision in the Act / Rules regarding casting of one vote of practitioner or teacher.

Point No. 11: Amendments in UAH Act, 1965-2002.

Discussed and decided at point no. 9.

Point No. 12: Drug Regulatory Authority of Pakistan (DRAP).

Homoeopathic Doctor Javed Akhter proposed that one Homoeopathic Doctor must be nominated for DRAP Policy Board, having Pharmacy qualification/background. This post is vacant and DRAP is issuing SRO's without the consent of stake holders, which is illegitimate. Without having representative in the policy board, the rules framed for homoeopathy by the DRAP are not legal. **After discussion the House resolved that name of President NCH may be included in the policy board as expert being Representative of Homoeopathic Community as notified by the Federal Government in past and to make a request to the DRAP for appointment of a qualified Homoeopathic Doctor (Diploma or Degree Holder) in every Pharmacy registered/enlisted with DRAP in the light of DRAP Rules.**

Point No. 13: Pharmacy Council.

Not allowed by the house as related with Pharmacy Council.

Point No. 14: Affairs of Homoeopathic Medical Colleges.

Homoeopathic Doctor Javed Akhter presented some proposals for improvement of Homoeopathic Medical Colleges. He stated that time should be given to colleges to meet the requirement of NCH Yard Stick. The Teachers should be at least M.Sc if you want to equate Diploma upto B.Sc. Principal be appointed in Homoeopathic Medical Colleges should have at least graduate having 10 years of teaching experience / practice plus the teaching staff should have teaching certificate. Homoeopathic Medical College may be affiliated to General / Homoeopathic Universities for conducting DHMS Diploma Course Studies / BHMS Degree Program. **After some discussion the House resolved that every college is bound to operative his college Dispensary within next 06 months. In case of non-functional of college dispensary, House Job Certificate of this college being issued to the students will not be accepted by NCH. Homoeopathic Doctor Rao Ghulam Murtaza, Vice President and Homoeopathic Doctor Muhammad Moin Khan were assigned the task to implement this decision. Moreover, every Homoeopathic Medical College should hire one BHMS Degree holder in Teaching Staff.**

Point No. 15: Service Structure of Homoeopathic Doctors.

Homoeopathic Doctor Javed Akhter stated that to stream line the service structure of employed Homoeopathic Doctors NCH should write a letter to all four provinces through Ministry to bring amendment in employee's service structure for setting equal status and salary packages as compared to the other medical cadres. **The House agreed with his proposals and resolved that a letter wrote to the Secretary Health K.P.K. for service structure of employed Homoeopathic Doctors**

Point No. 16: National Health Policy.

Homoeopathic Doctor Javed Akhter stated that in Unani, Ayurvedic and Homoeopathic Act, 1965, it is responsibility of the Federal Government that has to take

step for the improvement of Homoeopathic System of Medicine with mutual cooperation of NCH. Homoeopathy should be included in National Health Policy. Government should establish four ideal Homoeopathic Medical Colleges in all four provinces, to set a standard of imparting of Homoeopathic Education. The House referred the matter to Homoeopathic Doctor M.B. Jawed Awan, Chairman Steering / Executive Committee for examination and proposal to be put up in next meeting.

Point No. 17: Passing of Homoeopathic Drug Act.

Homoeopathic Doctor Javed Akhter stated that the present Drug Act does not meet the entire requirement of Homoeopathic medicines, therefore, Homoeopathic Drug Act should be passed from the Parliament. After discussion, the House resolved that Homoeopathic Drug Act is not feasible in the existing of DRAP. However, matter referred to the Act, Rules/Regulations Committee for necessary consideration and put up before the next meeting of the Council.

Point No. 18: Establishment of Homoeopathic Research and Teaching Hospital

The point has already been discussed and decided at point no. 6-Members identical points.

Point No. 19: Employment of Homoeopathic Doctors

Homoeopathic Doctor Javed Akhter stated that Homeopathic Graduates may be given chance to appear in PPSC and FPSC examination like MBBS doctors to contest for civil servant seats. As DHMS diploma has been equated to B.Sc (Homoeo) by the Federal Urdu University and HEC not only approved the BHMS Syllabus but also issued equivalency to BHMS upto M.Sc, therefore, DHMS and BHMS doctors both should be given basic scale 17 in Federal and Provincial Government Institute / Hospitals. The House agreed with his proposal and resolved that case will be discussed with the Federal / Provincial authorities.

Point No. 20 : Amendment in NCH Pharmacopoeia.

Homoeopathic Doctor Javed Akhter stated that NCH must publish brochures / pamphlets on newly proved medicines. Although review of homoeopathic pharmacopoeia should be made to add new proved remedies and common emergency medicines. Surgical / Clinical instruments / apparatus / items and transfusion medicines / liquids should be included in pharmacopoeia to facilitate homoeopaths to handle all type of minor surgery and emergency patients. Referred to the Drug and Pharmacopoeia Committee for his further examination and report.

Point No. 21: NCH Examining Body.

The point has already been discussed and decided at point no 2.

Point No. 22: Livestock and Homoeopathy.

Homoeopathic Doctor Javed Akhter stated that there is no curative treatment available against viral diseases. Homoeopathic medicines are effective in Animal

diseases. In foreign countries, people are treating their pets and farm house animals with homoeopathic medicines. Efforts should be made to work on this ground also. Homoeopathic injection should be made to inject homoeopathic medicines for animal treatment. Advice may be given to Govt. to promote Homoeopathic Veterinary Products and Treatment Referred to the Research Committee for examination as well as to Syllabus Committee for inclusion of chapter in DHMS Syllabus.

Point No. 23: Gynae Practice.

Homoeopathic Doctor Javed Akhter stated that a lady Homoeopathic Doctor may allow to help woman in labour procedure with use of all necessary medicines and equipment. The House referred to Act, Rules/ Regulations Committee for more consideration.

Point No. 24: NCH Research Committee.

The point has already been discussed and decided at point no 2.

HOMOEOPATHIC DOCTOR TARIQ KHAN

Point No. 1: To impose a check at every possible point of corruption in NCH. Any method must be evolved to check and tally the amount received for registration or renewal and action taken against it.

Homoeopathic Doctor Tariq Khan proposed to impose a check at every possible point of corruption in NCH. Any method must be evolved to check and tally the amount received for registration or renewal and action taken against it. The chair invited the mover to visit the office of NCH on any working day and check and verify each and every thing. The mover not pressed further.

Point No. 2: Withdrawal of letter of Ex-administrator Mr. Shakeel Qaisar Kayani regarding verification of matric certificate for renewal / registration. If necessary this should be applicable only for fresh registration and first renewal of registration.

The point has already been discussed and decided at point no 28 of page 24.

Point No. 3: To update the final admission list on website in time as per Rule 10.

The point has already been discussed and decided. To be implemented on development of new software. Point No. 3 at page 9 & 12 of page 14-15.

Point No. 4: To curtail the expenses of NCH by voiding unnecessary expenditure on travelling.

The President assured that NCH should curtail the expenses of NCH. However, mover was invited to visit the office of NCH on any working day to check each and every receipt and payment and make concrete suggestions in this regard to further place before the Council in next meeting.

Point No. 5: To hold meeting with HEC and Pakistan Pharmacy Council to include Chapters on Homoeopathic Pharmacy and Homoeopathy in the syllabus of Pharm D.

The President informed that NCH suggested amendment in UAH Act, 1965 for starting D-Pharm (Homoeo) Course in 2012 but unfortunately the same is still pending in the ministry. **The House referred the proposal to Syllabus Committee and mover was requested to present his in-put to the committee accordingly.**

Point No. 6: To take measures to make the examination system of DHMS and BHMS more transparent and economical by establishing one neutral Examination Hall district wise.

The House partially disagreed with the proposal regarding establishment of whole examination centres in neutral places keeping in view of past experience. Further referred to the Examining Body for consideration and implementation, if feasible.

Point No. 7: To update the existing syllabus of DHMS and BHMS according to uprisng IT needs.

The Chaired proposed that all Homoeopathic Medical Colleges be advised to establish Computer Labs immediately. **Further matter referred to the Syllabus Committee for examination.**

Homoeopathic Doctor Tariq Khan thanked the house on discussion of his all points in a good manner.

HOMOEOPATHIC DOCTOR IRUM NAZ AKHTAR

Point No. 1: Formulation of Homoeopathic Policy

Homoeopathic Doctor Irum Naz Akhter referred preamble of the Act and stated that a committee of scientists be constituted who should be responsible to study the policies of the regional countries their stratagem, principles or proposed course of actions, systems and guide lines in order to formulate a concrete policy for recommendations to be forwarded to the government for their prudent or expedient conduct or action. **After discussion matter referred to the Chairman Steering / Executive Committee – Homoeopathic Doctor M.B. Jawed Awan for preparation of 5th Years Development Plan, which will be presented in the next Council's meeting.**

Point No. 2: Research Centre

The point has already been discussed and decided at point no 6-members identical points.

Point No. 3: Establishment of Nucleus Centre

The point has already been discussed and decided at point no 6-members identical points.

Point No. 4: Establishment of Working Cubicles

Homoeopathic Doctor Irum Naz Akhter state that at present the premises allocated to the Council is an open hall; with open seating arrangement. A number of cubicles should be created with work stations to give it a look of formal working. **The House agreed with the proposal and mover was requested to provide suggestions relating to Information Technologies.**

HOMOEOPATHIC DOCTOR M.B. JAWED AWAN

Point No. 1: Revision of amendments in Unani, Ayurvedic and Homoeopathic System of Medicine Rules Rules, 1980 circulated vide SRO No. (1)/2018 dated 19th October 2018. These rules are quite different as recommended by the Council.

The House referred the matter to Act, Rules & Regulation Committee who will study the SRO issued recently by the Federal Government and propose suitable amendments in the Rules.

Point No. 2: Fate of amendments proposed in the Examination Regulations submitted to the Federal Government for approval along with Rules 1980.

The Chair informed the House that amendments were proposed in the Homeopathic Examination Regulations, 1986 and sent to the Federal Government in 2012 for approval but unfortunately as yet the same is pending in the Ministry. **The Assistant Director (Homoeo), who was present in the meeting was requested to expedite the matter.**

Point No. 3: Approval of the Five Years Development Program of the Council.

The Chair requested to the Chairman Steering Committee to prepare 5 Years Development Plan and put in next meeting of the Council.

Point No. 4: Punjab Government's policy of recruitment of Homoeopathic Doctors-ban on fresh appointments and declaring homoeopathy as dying cadre.

After discussion the House resolved to hold a meeting with the Health Minister of the Government of the Punjab on the issue as early as possible

HOMOEOPATHIC DOCTOR RAHEEL MUHAMMAD

Point No. 1: Implementation of present Syllabus.

Homoeopathic Doctor Raheel Muhammad stated that present DHMS Syllabus is sufficient, comprehensive for the students and suggested for its strictly implementation. **After discussion the house resolved that a letter wrote to HMC Colleges for strictly implementation of existing DHMS Syllabus with direction to use only recommended books and not to use short books like U.A. Chaudhary etc.**

Point No. 2: Strategy for attendance of students.

Homoeopathic Doctor Raheel Muhammad showed his serious concerns about poor attendance of the students in Homoeopathic Medical Colleges and requested the house to take steps for improvement. **The House decided that:-**

- a) **One Time Table for all H. M. Colleges, which will be issued by Controller of Examinations.**
- b) **2 Examinations in a year under the control of Examining Body.**
- c) **Hahnemann Day / National / Cultural / Sports Day shall be celebrated in all H.M. Colleges.**
- d) **Inter-College competition, speeches and Naa't competition shall be arranged.**

Point No. 3: Partition in NCH i.e. Registrar, Controller Office, Room for Members and every Section of NCH.

The point has already been discussed and decided at point no 3.

Point No. 4: Up-gradation of Computer Section

The point has already been discussed and decided at point no 3.

Point No. 5: Copying during examinations.

The point has already been discussed and decided at point no 8 of Homoeopathic Doctor Saeed ur Rehman Khattak at page 34.

Point No. 6: Teachers Training Courses

The point has already been discussed and decided at point no 4-Members identical points.

Point No. 7: Examination Staff workshops.

The point has already been discussed and decided at point no 4-Members identical points.

Point No. 8: Meeting with Ministry to increase Annual Budget.

The point has already been discussed and decided at point 3 at page 9-10.


**11TH WORLD CONGRESS ON COMPLEMENTARY & ALTERNATIVE MEDICINE
