

2. Meeting started at 11:00 AM. Homoeopathic Doctor Waheed Ahmad recited the verses from the "HOLY QURAN". Homoeopathic Doctor Siddique Ali Ansari offered Na'at Sharif. The meeting chaired by the President - Homoeopathic Doctor Mahmood ul Haq Abbasi. The President welcomed the all members.

**Agenda Point No. 1: To confirm Minutes of previous 149<sup>th</sup> Regular Meeting of NCH held on 27-29 December 2018.**

The President presented first point of Agenda before the House. The Registrar stated that no objection letter was received from any member except Homoeopathic Doctor Muhammad Irfan Wali, which was read out before the House. The House accepted his objection and allowed to include his name in the Inspection Committee in place of Homoeopathic Doctor

Irum Naz Akhter. As no other objection was raised by any member, therefore, the House unanimously confirmed the minutes of previous 149<sup>th</sup> (Regular) Meeting.

**Agenda Item No. 2: To Confirm Minutes of Syllabus Committee Meeting held on 28<sup>th</sup> January 2019.**

The President put up next agenda item and read out Minutes of the Syllabus Committee Meeting held on 28<sup>th</sup> January 2019 before the house. The chair requested Chairman Syllabus Committee to give his in-put on the syllabus.

2. Homoeopathic Doctor Ilahi Bux proposed some amendments at page No. 3, 4, 5, 10, 11, 13 and 14 of the Curriculum & Syllabus of First 2 Years which accepted by the House and subject of Pakistan Studies was replaced with Urdu.

3. Homoeopathic Doctor Javed Akhter stated that SOPs should not be adopted and expert opinion is required in case of any mistake before revision and approval of this syllabus. The President replied that all SOPs have been adopted in this regard. He further stated that even member of this august house not seen the syllabus carefully.

4. Homoeopathic Doctor Muhammad Tariq Khan and Homoeopathic Doctor M.B. Jawed Awan proposed to change Computer Science with Computer Proficiency in First Year (at page-14), which was allowed by the house. Homoeopathic Doctor Faisal Saleem and Homoeopathic Doctor Saeed ur Rehman Khattak opposed on inclusion of Computer Science subject in the syllabus. Homoeopathic Doctor Siddique Ali Ansari also disagreed with the Computer Science subject. He requested the Chair for timely supply of documents / information from the office for preparation. Homoeopathic Doctor Naeem Hafeez supported to include the Computer related subject in the syllabus.

5. Homoeopathic Doctor M.B. Jawed Awan stated that this syllabus was approved by the Federal Government during the tenure of the Council when Homoeopathic Doctor Abdul Qadeer was working as Assistant Director Ministry of Health.

**Decision:**

*The House confirmed the Minutes of Syllabus Committee meeting held on 28<sup>th</sup> January 2019 and approved proposed Curriculum and Syllabus for Homoeopathic Institutions – DHMS 1<sup>st</sup> to 4<sup>th</sup> Year with changes which were proposed by the members. The House authorized Homoeopathic Doctor Saeed ur Rehman Khattak, Chairman Syllabus Committee and Homoeopathic Doctor Ilahi Bux, Chairman Act, Rules & Regulations Committee to review and incorporate amendments in the syllabus as per discussion and submit a fair and final copy for onward submission to the Ministry.*

**Agenda Item No. 3: To confirm Minutes of Inspection Committee Meeting held on 7<sup>th</sup> March 2019**

The President presented next agenda item regarding confirmation of minutes of the Inspection Committee meeting held on 7<sup>th</sup> March 2019 and stated that inspection schedule of Homoeopathic Medical Colleges for the year 2019-20 has already been finalized and approved by the Inspection Committee in its meeting which was already circulated amongst the members of the Council. As per decision of the committee, inspection team will be consisted on 2 members i.e. one from the same province and one from the other province. The President, Vice President, Chairman Inspection Committee or Registrar is authorized to join any inspection team at any time at their own convenience.

2. Homoeopathic Doctor Javed Akhter stated that inspections should be resulted oriented otherwise it will be wastage of Council funds. Colleges should be inspected only on receipt of any complaint from any corner. He questioned that what criteria and ratio of assignment was adopted on the distribution of H.M. Colleges.

3. Homoeopathic Doctor Ilahi Bux and Homoeopathic Doctor Saeed ur Rehman Khattak suggest to conduct inspections of Homoeopathic Medical Colleges immediately as the HOLY Month of Ramzan ul Mubarak will start in May 2019.

4. Homoeopathic Doctor M.B. Jawed Awan referred Section 18 of the UAH Act, II of 1965 and stated that inspections are mandatory and it is duty of the Council to secure the maintenance of an adequate standard of efficiency in recognized institutions. It is not misuse of funds.

5. Homoeopathic Doctor Muhammad Moin Khan supported the inspection of Homoeopathic Medical Colleges.

6. Homoeopathic Doctor Muhammad Tariq Khan stated that inspection must be different from the past and accurate. He stressed for equal distribution and suggested to review the Inspection Schedule.

7. The Vice President stated that inspection should be carried out to improve the standard of efficiency and mandatory as per Section 18 (4) of the Act. He requested the house to approve minutes of the meeting and inspection schedule as earlier circulated amongst members of the Council.

**Decision:**

*The House warned to Homoeopathic Doctor Javed Akhter for using the words of "misuse of funds". Distribution of inspection's assignments amongst members will be reviewed. For this purpose a committee comprising of the President, Vice President and Chairman Inspection Committee was constituted. Further the House confirmed the minutes of*

*Inspection Committee meeting. It was decided that in future, any matter related with any committee, should be sent to the concerned chairman of the committee.*

**Agenda Item No. 4 : To confirm Minutes of Act, Rules, Regulations Committee Meeting held on 8<sup>th</sup> March 2019**

The Chair put up next agenda item and stated that Minutes and proposed Draft of UAH Act, 1965 was circulated amongst the members of the Council. He requested the house for any proposal or objection on the proposed Draft. No proposal or objection from any member was received. Therefore, the House confirmed the Minutes of the Act, Rules & Regulations Committee and approved proposed separate Draft namely "The Homoeopathic Act 2019" unanimously as directed by the Ministry of NHR&C vide letter No. F. 1-27/2016-Unani/Homoeo dated 31<sup>st</sup> August 2018, with a direction to the committee that meeting may be rescheduled for finalization of remaining amendments in Rules/Regulations.

**Agenda Item No. 5: To Discuss constitution of Examining Body NCH**

The President NCH presented next agenda item regarding re-constitution of Examining Body NCH and informed the house about the discussion held with the Director General (Health) and Director (Regulations) Ministry of National Health Services, Regulations & Coordination Islamabad on the issue of notification of Examining Body NCH. After discussion the House unanimously re-constituted the following examining body in the light of discussion held between the DG (Health) and Director (Regulations) M/o NHR&C and directed Registrar to forward the same to the Ministry for notification :-

**Agenda Item No. 6 : To discuss the matter regarding constitution of Selection Committee of NCH**

The President presented next agenda item and directed Registrar to brief the House. The Registrar informed the House that the ministry during the tenure of Administrator, approved DPC/DSC of NCH vide letter No. F. 1-3/2017-AD (U/H) dated 26<sup>th</sup> February 2019 comprising of Additional Secretary, Joint Secretary and BPS-19 Officer of the concerned Department otherwise DS (concerned) of the ministry for appointment in BPS-17-19, Joint Secretary (Admn.), Deputy Secretary (Admn.) and BPS-19 Officer of the concerned Department otherwise DS (concerned) of the ministry for appointment in BPS-11-16 and Deputy Secretary (Concerned), Section Officer (BPS-18) concerned and Registrar (BPS-17) / Section Officer (BPS-18) of ministry for appointment in BPS-1-10. The said DPC/DSC is against the Regulation 2 (f) NCH Staff Service Regulations, 1987. On taken over charge by the existing Body, the Ministry was requested vide letter No. NCH/F. 5-24/2018-3913 dated 31<sup>st</sup> December 2018 for approval of Selection Committee comprising of members of NCH as required vide Regulation 2 (f).....*Selection Committee” means the Selection Committee constituted by the Council amongst its members for the purpose of selection and appointments of staff in accordance with the Establishment Division OM No. 6/4/96-R-3 dated 10<sup>th</sup> May 1997, amended from time to time.* Despite of repeated reminders and requests for approval of recommended Selection Committee, the Ministry of NHR&C insisted to complete the recruitment process of vacant posts through the DPC/DSC (Comprising of Ministry’s Officers) earlier constituted vide letter dated 26<sup>th</sup> February 2018.

2. Homoeopathic Doctor Ilahi Bux proposed to re-recommend the same committee and request to the ministry to approve it accordingly as constituted by the Council.

**Decision:**

*The House showed serious concerns on the matter regarding non-approval of Selection Committee as recommended by the Council and decided to forward a fresh letter to the Ministry with request to grant approval immediately.*

**Agenda Item No. 7: To discuss and confirm the Minutes of Meeting held with Assistant Director (Homoco) on 6<sup>th</sup> February 2019.**

The President put up next agenda and requested the house to confirm minutes of meeting as already circulated amongst the members of the Council. Homoeopathic Doctor Ilahi Bux suggested that National Drug Laboratory Karachi may also be approached for establishment of Research Centre and Testing Laboratory. After some discussion the House confirmed the minutes with some minor changes.

**Agenda Item No. 8: To discuss and approve recommendations received from the committee comprising of Homoeopathic Doctor M.B. Jawed Awan, Ilahi Bux and Saeed ur Rehman Khattak, members NCH on Magnet Therapy.**

The President read out the recommendation / report dated 08-03-2019 of the Committee before the House. The Chair requested Homoeopathic Doctor M.B. Jawed Awan on the issue. He briefed the House on the Magnet Therapy. *The House disagreed with the recommendations of the committee and resolved to revisit and re-submit report / recommendations in next meeting of the Council.*

**Agenda Item No. 9 : To discuss Assistant Director (Homoeo) Khyber Pakhtun Khwa letter No. 685-87/Homoeo/Tibb dated 06-03-2019 regarding preparation of course / criteria for Homoeo Dispenser**

The Chair read out letter dated 06-03-2019 received from the Assistant Director (Homoeo) Khyber Pakhtun Khwa before the House. Homoeopathic Doctor Tariq Khan suggested that the word Homoeo. Pharmacist may be replaced with Homoe.o Dispenser. *The House after some discussion referred the matter to Syllabus Committee. The Committee will submit Draft Syllabus for Homoeo Dispenser Course in next meeting of the Council.*

**Agenda Item No. 10 : To discuss Homoeopathic Doctor Malik Aamir Shaheen Cheema (Karachi) letter dated 16<sup>th</sup> March 2019 regarding clarification of Hijama Therapy practice by Homoeopaths.**

The President read out letter No. NCH/01/004 dated 16<sup>th</sup> March 2019 received from Homoeopathic Doctor Malik Aamir Shaheen Cheema (Karachi) regarding clarification of Hajama Therapy practice by a registered Homoeopathic Practitioner. He raised following questions in his letter:-

- i) Is Hijama Therapy being taught during 4 year DHMS & 5 years BHMS?
- ii) Is Hijama Therapy included in the approved curriculum of the Council or HEC?
- iii) Is a Registered Homoeopathic Practitioner legally /sheltered by the NCH, for practicing Hijama under its registration

2. Homoeopathic Doctor Saeed ur Rehman Khattak, Homoeopathic Doctor M.B. Jawed Awan, Homoeopathic Doctor Siddique Ali Ansari, Homoeopathic Doctor Ilahi Bux, Homoeopathic Doctor Naeem Hafeez, Homoeopathic Doctor Rao Ghulam Murtaza and Homoeopathic Doctor Muhammad Asif Khan took part in the discussion and opposed Hijama Therapy by Registered Homoeopathic Practitioners as there is no provision/chapter is available in the Curriculum and Syllabus of BHMS and DHMS.

3. Homoeopathic Doctor Ilahi Bux stated that NCT contacted with Sindh Healthcare Commission for this purpose also.

The captioned point was deferred for next meeting.

**Agenda Item No. 12: To discuss letter dated 16-03-2019 regarding Education (DHMS & BHMS) of Homoeopathic Doctor Muhammad Irfan**

The Chair read out letter dated 16-03-2019 of Homoeopathic Doctor Muhammad Irfan, Sadar Chowk, Sadar Bazar, Mansoorabad, Faisalabad, before the House. After discussion the House resolved as under:-

- a) *Part one: Enhancement of basic qualification for admission in DHMS 4 Year program from Matriculation to F.Sc (Pre-medical) is being implemented.*
- b) *Part Two: The matter relating to imparting education in splitted manner is not feasible in any way therefore the House unanimously rejected the same.*

**Agenda Item No. 13: To discuss complaint received from Section Officer (H&D) Primary & Secondary Healthcare Department Lahore vide letter No. SO (H&D)7-15/2012 (Homoeo) dated 4<sup>th</sup> February 2019 against Allied HMC Okara.**

The chair read out complaint against Allied Homoeopathic Medical College Okara received through Section Officer (H&D) Primary & Secondary Healthcare Department Government of the Punjab Lahore before the house. After discussion the House resolved that inspection of Allied HMC Okara will be carried out by the inspection team as already constituted by the Inspection Committee comprising of Homoeopathic Doctor M.B. Jawed Awan and Homoeopathic Doctor Siddique Ali Ansari, Members of NCH.

**Agenda Item No. 14: To discuss matter regarding cancellation of registration of Homoeopathic Doctor Faisal Umer (Rawalpindi).**

The President presented next agenda items and directed Registrar to brief the House. The Registrar stated that on receipt of complaint from Mr. Tausif Ahmad Abbasi, Staff Reporter Daily Jinnah Islamabad against Homoeopathic Doctor Faisal Umer, House No. A-3/309, Westrage-1, Peshawar Road Rawalpindi (Registration No. 105919), he was called for personal hearing on 13<sup>th</sup> August 2018 vide letter dated 6<sup>th</sup> August 2018, on 20<sup>th</sup> August 2018 vide letter

dated 15<sup>th</sup> August 2018, 14<sup>th</sup> January 2019 vide letter dated 7<sup>th</sup> January 2019 and 25<sup>th</sup> February 2019 vide letter dated 11<sup>th</sup> February 2019 but he failed to attend the hearing. He also refused to receive letters of NCH. Finally a show cause notice was publicized in the Daily Jang (Rawalpindi and Jinnah (Rawalpindi) therein he was advised to attend the office of NCH within 07 days alongwith all original documents related with your DHMS but he failed to do so. He informed the house that all possible steps were taken in this case but Homoeopathic Doctor Faisal Umer does not cooperate with the office. He proposed to cancel his registration No. 105919 and Renewal No. 38175 under Section 28/29 of the UAH Act, 1965. *The House unanimously resolved to cancel registration and renewal of Homoeopathic Doctor Faisal Umer (Rawalpindi) under Section 28/29 of the Act, 1965 immediately.*

**Agenda Item No. 15: To discuss matter regarding cancellation of registration of Homoeopathic Doctor Muhammad Arshad (Sumandari) in the light of inquiry conducted by PHC**

The chair presented next agenda point and directed Registrar to brief the house. The Registrar informed the house that decision of the Board of Commissioners Punjab Healthcare Commission, Lahore was received vide letter No. C/2016/151 dated 14<sup>th</sup> May 2018 against Homoeopathic Doctor Muhammad Arshad S/o Allah Rakha (Registration No. 69305). The Board of PHC recommended that *"NCH be approached for action against Mr. Muhammad Arshad for stocking and selling allopathic medicines, in violation of Section 33 (2) of the Unani, Ayurvedic and Homoeopathic Practitioners Act, 1965"*. The matter was inquired during the tenure of Administrator. The Chairman Registration and Renewal Committee Homoeopathic Doctor Faisal Saleem also visited his clinic on 13-12-2018 and submitted report. The said report was read out before the house. The Chairman Registration and Renewal Committee recommended to cancel his registration because he is still involved illegally in stocking and selling allopathic medicines in his store. *The House unanimously resolved to cancel registration of Homoeopathic Doctor Muhammad Arshad S/o. Allah Rakha under Section 28 of UAH Act, 1965 immediately.*

**Agenda Item No. 16: To discuss application submitted by Homoeopathic Doctor Nasir Mahmood Bhatti and Homocopathic Doctor Muhammad Intiaz Gondal for award of title of Professorship**

The President put up next agenda and read out application of both Homoeopathic Doctors before the House. Homoeopathic Doctor Aisha Nawaz proposed that the said matter may be referred to the Fact Finding Committee. The President suggested constituting a committee comprising of Chairman Registration / Renewal Committee, Chairman Education & Monitoring and Equivalence Committee and Chairman Syllabus Committee for examination and recommendation. *After discussion the house agreed with the proposal and decided the following TORs of the Committee:-*

- a) To examine both applications as per existing criteria.
- b) To determine fresh criteria for award of title Professorship keeping in view of existing criterion & draft will be put up before the next Council's meeting.
- c) To examine / review all cases of title of Professorship previously awarded by the Council.

**Agenda Item No. 17: To discuss and approve matter of up-gradation of the post of Steno-typist BPS-12 to 14 of MS Noor Fatima in the light of Ministry's letter dated 18<sup>th</sup> December 2018.**

The President present next agenda item and directed Registrar to brief the case. The Registrar informed the House that the Federal Government upgraded the post of Steno-typist from BPS 12-14 vide Finance Division O.M. No. 19 (55)/Legal-II/2010-1055 dated 23<sup>rd</sup> December 2011. MS Noor Fatima is working in NCH as Steno-typist in BPS-12 since her appointment. Her case was forwarded to the Federal Government during the tenure of Administrator for approval of up-gradation from BPS-12 to 14. After lengthy correspondence, the Ministry vide letter dated 18<sup>th</sup> December 2018 requested to place the case before the Council for its approval. After detailed discussion the House resolved that:-

- a) *Matter of up-gradation of the post of Steno-Typist from BPS 12-14 referred to the Selection Committee for consideration.*
- b) *Revise Schedule 5(2) of NCH Staff (Service) Regulations, 1987, of other staff i.e. LDC, UDC, Assistant and Accountant in the light of O.M.s issued by the Federal Government from time to time.*
- c) *Create new posts as per requirement.*

**Agenda Item No. 18: To discuss Audit Para No. 2 regarding irregular expenditure on hiring services of Hotel amounting to Rs. 4.819 million in the light of Audit & Inspection Report for the FY (2013-2017).**

The Chair directed Registrar to brief the house about next agenda item. The Registrar informed that Directorate General Audit (Federal Government) Islamabad raised audit para in Audit & Inspection Report on the accounts of NCH for the FY 2013-17 regarding irregular expenditure on hiring the services of hotels – Rs. 4.819 million. The Audit authority is of the view that Rule 12 (1) of the Public Procurement Rules states that procurements over one hundred thousand rupees and up to the limit of two million rupees shall be advertised on the Authority's website in the manner and format specified by regulation by the Authority from time to time. These procurement opportunities may also advertise in print media, if deemed necessary by the procuring agency. The audit para was discussed in the Departmental Accounts Committee (DAC) meeting held on 26-04-2018. The DAC directed the NCH management to regularize the procurement of hotel services from competent forum of the Council. After discussion, the house unanimously regularized/approved the amount of Rs. 4.819 million incurred on account of hiring services of Hotel for members of NCH.

**Agenda Item No. 19: To discuss Audit Para No. 3 regarding irregular expenditure on account of Member's TA/DA amounting to Rs. 10.0887 million in the light of Audit & Inspection Report for the FY (2013-2017).**

The Chair directed Registrar to brief the house about the agenda item. The Registrar informed the house that Directorate General Audit (Federal Government) Islamabad raised audit para in Audit & Inspection Report on the accounts of NCH for the FY 2013-17 regarding irregular expenditure on account of TA/DA of Members of NCH amounting to Rs. 10.087 million. The audit authority is of the view that travelling allowance claimed by the members including travelling by car /taxi in absence of railway facility @ Rs. 10/- per kilometer without approval of competent authority for own car instead of Rs. 2.50 per kilometer. The audit para was discussed in the Departmental Accounts Committee (DAC) meeting held on 26-04-2018. The DAC directed NCH management to get ex-post facto approval of tour programs of all members of Council in relation to official visits, and directed to complete all codal formalities in the future. The DAC recommended the para for settlement subject compliance with above said directions. After discussion the House unanimously granted ex-post facto approval of Rs. 10.087 million on account of Member's T.A./D.A. and further directed Accountant to follow the instructions in letter and spirit.

2. Meeting started at 11:00 AM. Homoeopathic Doctor Tabassum Hussain recited the verses from the "HOLY QURAN". Homoeopathic Doctor Siddique Ali Ansari offered Na'at Sharif. The meeting chaired by the President - Homoeopathic Doctor Mahmood ul Haq Abbasi. The house offered Fateha for Homoeopathic Doctor Zaheer (Naushehra), mother of Homoeopathic Doctor Junaid Akhter Bukhari, ex-member NCH (Karachi) and wife of late Homoeopathic Doctor Syed Ather Ahmad Bukhari (Bahawalpur) and pray "ALMIGHTY ALLAH" for the resting of their soul in eternal peace and grant patience to the members of their families.

**Agenda Item No. 20: To discuss M/o NHR&C letter dated 14<sup>th</sup> March 2019 and its reply submitted to Ministry vide letter dated 20<sup>th</sup> March 2019 and 26<sup>th</sup> March 2019 regarding complaint of Chairman HPCA.**

The chair read out M/o NHR & C letter dated 14<sup>th</sup> March 2019 and NCH reply submitted vide letter dated 20<sup>th</sup> and 26<sup>th</sup> March 2019 before the House. He briefed the house about whole matter. **The House shows serious concerns on the Ministry's letter, reply was approved and the President was authorized to decide the matter accordingly.**

**Agenda Item No. 21: To discuss matter regarding explanation and Show Cause Notice served to Homoeopathic Doctor Muhammad Tayyab, Chairman HPCA.**

The President informed the House that a complaint was filed by Homoeopathic Doctor Muhammad Tayyab at the Ministry of NHR&C Islamabad, in which he stated that the President is misguiding to the Homoeopaths local industry, importers and its traders that the issuance of Form 6 & 7 will be through NCH. He misguided to the Honourable Minister for Health. He defame the Council as well President through false, fabricated and baseless statements without having any evidence and committed misconduct. He also used the title of Dr. instated of Homoeopathic Doctor. The Registrar issued a show cause notice and called explanation from Homoeopathic Doctor Muhammad Tayyab, therefore, the House is requested to approve show cause notice and explanation letter. **The house granted approval regarding issuance of show cause notice and explanation to Homoeopathic Doctor Muhammad Tayyab.**

**Agenda Item No. 22: To discuss matter relating to change of Building of Lahore HMC Lahore.**

The President read out letter dated 19-02-2019 of the Principal Lahore HMC Lahore regarding change of building. **The House constituted a committee comprising Homoeopathic Doctor M.B. Jawed Awan and Homoeopathic Doctor Waheed Ahmad who will inspect the proposed building of Lahore HMC Lahore.**

The President put up next agenda point and read out application of Mr. Tariq Mahmood, Superintendent for motor car advance. *The house unanimously approved motor car advance as per existing policy / criteria as determined by the Finance Division vide O.M. No F, 8(2)-Reg. 7/87-698 dated 9<sup>th</sup> January 2018.*

**Agenda Item No. 24: To discuss the matter regarding pensionary benefit of NCH employees to be registered with employees Old Age Benefits (EOBI).**

The President put up next agenda item and informed the house that no pensionary benefit is available to allow the NCH employees except Contributory Provident Fund. The previous Council in its 140<sup>th</sup> (Resumed) meeting which was held on 17<sup>th</sup> December 2013 granted approval for registration of NCH with Old Age Benefits Institution but unfortunately as yet the matter of registration and deposit of contribution is pending. *The house constituted a committee comprising President, Vice President and Chairman Finance Committee to look into the matter and decide accordingly.*

**Agenda Item No. 25: To discuss the matter of advertisement policy by NCH on electronic, print and Social Media.**

The President referred decision of the Council taken in its last 149<sup>th</sup> Regular meeting held on 27<sup>th</sup> to 29<sup>th</sup> December 2018 and requested Chairman Advertising Committee to present Policy/SOPs on the Advertisements. Homoeopathic Doctor Muhammad Tariq Khan, Chairman Advertising Committee handed over a copy of Terms of Reference - Advertisement to the President NCH. *The chair decided to circulate it amongst members for their study and in put before next meeting of the Council.*

**Agenda Item No. 26: To discuss unethical Advertisement by Homoeopathic Doctor Ibrar Hussain Naqvi, and Homoeopathic Doctor Hanif Malik Faisalabad.**

The chair presented next agenda items and read out complaints received against Homoeopathic Doctor Ibrar Hussain Naqvi, Homoeopathic Doctor Hanif Malik (Faisalabad) and Homoeopathic Doctor Mian Liaquat Ali (Lahore) on account of their involvement in unethical advertisements in print, electronic and social media. *After discussion, the house referred the matter to Chairman Registration, Renewal and Code of Ethic Committee.*

**Agenda Item No. 27: To discuss Inquiry Report of H.M. Colleges during March Test.**

a) **Al-Furqan HMC Jampur**

The chair invited Controller of Examinations to brief the house. Controller of examination informed that on receipt of complaint from inspector an inquiry

committee comprising of Vice President, Homoeopathic Doctor Tabassum Hussain and Controller of Examinations was constituted. The committee visited the college on 5<sup>th</sup> April 2019. He read out inquiry report before the house and stated that the inquiry committee is of the view that the college is sub-standard and found no sign of conduction of March Test in the college premises.

ii) The chair stated that not a single student was appeared during the course of March Test 2019. Homoeopathic Doctor M.B. Jawed Awan suggested that show cause notice may be issued to the college. Homoeopathic Doctor Rao Ghulam Murtaza stated a Ta'aleemi Madrissa is also running there while his owner residing in London. He also recommended show cause notice, black list his centre and annual inspection may be carried out immediately. Homoeopathic Doctor Javed Akhter seconded his view point. The House decided that the said college shall not be declared as Examination centre in future. The inspection should be carried out as per schedule program / inspection team.

b) Faran HMC Sargodha

The chair stated that Homoeopathic Doctor Muhammad Irfan Rabbani was deputed as Inspector in Faran Homoeopathic Medical College, Sargodha. He submitted his report against the Principal Faran HMC Sargodha. The chair read out report before the house. According to report the Principal misbehaved with the Inspector and forcefully insisted to mark attendance of absent students. He threatened the Inspector awful consequences if not obeyed. The chair stated that the Principal misconducted with the Inspector who was appointed by NCH and proposed strict action against the Principal.

ii) Homoeopathic Doctor Naeem Hafeez stated that numerous complaints were received by him against the Principal Faran HMC Sargodha. He briefed the house about the complaints.

iii) Homoeopathic Doctor Saeed ur Rehman Khattak stated that behavior of the Principal with Inspector is condemnable. He stated that Inspectors and Invigilators appointed by the Council are respectable and suggested to issue show cause notice to the Principal. Homoeopathic Doctor Irum Naz Akhter proposed to black list the Principal. The House black-listed the Examination Centre of the Faran HMC Sargodha for future and recommended show cause notice to the Principal on account of his misconduct with the inspector. Further inspection of the college should be carried out as per inspection schedule.

c) Jhelum HMC Jhelum

i) The chair stated that so many complaints have been received during March Test against Homoeopathic Doctor Javed Akhter, Member NCH, particularly he referred the visit of the honourable member at Jhelum HMC Jhelum, where he captured a picture of a student. He lectured to the students in different colleges. This is against the SOP framed for March test.

ii) Homoeopathic Doctor Javed Akhter clarified his position and stated that he visited the college for up-gradation of the system and not for the purpose of TA/DA.

iii) Homoeopathic Doctor Faisal Saleem drew attention of house towards letter issued by the Controller of Examinations regarding visit of members of NCH during the course of March Test. Why he visited the colleges beyond his jurisdiction as he belong to Khyber Pakhtunkhwa province.

iv) Homoeopathic Doctor Seed ur Rehman Khattak stated that Homoeopathic Doctor Javed Akhter is newly nominated as a member therefore his mistakes may be ignored. **The House show serious concern on attitude of Homoeopathic Doctor Javed Akhter. It was decided that Homoeopathic Doctor Javed Akhter should follow the UAH Act, 1965 and rules/regulations framed there – under in future.**

v) At this juncture Homoeopathic Doctor Muhammad Asif Khan referred the attendance sheets of Sukkur HMC Sukkur received through WhatasApp only. He questioned on the March Test conducted at Sukkur HMC Sukkur. The chair directed Controller of Examinations to put up all Attendance Sheets of Sukkur HMC Sukkur to him after meeting. **The house constituted a committee comprising of Homoeopathic Doctor Saeed ur Rehman Khattak and Homoeopathic Doctor Ilahi Bux for this purpose.**

vi) The Vice President stated that building of the Al-Qamar HMC Multan is sub-standard and working on stay order. In a building so many other institutions are running. **The house constituted a committee comprising of Homeopathic Doctor Tariq Khan and Raheel Muhammad for this purpose.**

vii) He further referred the complaint received from the Inspector against Attbah HMC Jauharabad and referred a message floated in college group from the Principal Attbah HMC Jauharabad. He showed his serious concern on this message and proposed to take strict action against the institution. After detail discussion the house resolved as under:-

- i) Constituted an Inquiry Committee comprising of Homoeopathic Doctor M.B Jawed Awan and Homoeopathic Doctor Javed Akhter in case of Attbah HMC Jauharabad.
- ii) Registrar, Controller of Examinations and Superintendent are bound to listen phone of NCH Members.
- iii) Staff WhatApps Group complaints will be put up on the same day to the authorized person.
- iv) Every Monday staff meeting will be arranged and Minutes will also be prepared.

**Agenda Item No. 28: To discuss inspection Report of Al-Sehat HMC Faisalabad (Dr. Shakoor)**

The chair put next agenda item and read out inspection report of Al-Sehat HMC (Dr. Shakoor) Faisalabad before the House. **The house approved the Inspection Report dated 10-04-2019 and decided to issue show cause notice to the college.**

Homoeopathic Doctor Javed Akhter read out recommendations of the inspection team.... *"At present the Mianwali Homoeopathic Medical College Mianwali does not meets the requirement of Yard Stick. However, the Management is advised to make up the deficiencies as pointed out above as early as possible. It is recommended to revisit the institution after removal of deficiencies."*

**Decision:**

**The House unanimously approved the Inspection Report of newly established Mianwali HMC Mianwali.**

- c) At this juncture, the Vice President informed the House that a complaint has been received against Pakistan HMC Lahore from President Pakistan Homoeopathic Medical College BHMS Department. He handed over a copy of the said complaint to the Chair. The Chair read out before the House. **The House decided to conduct inspect of both Department of Pakistan HMC Lahore (DHMS/BHMS) within 07 days through inspection teams already constituted by the Inspection Committee.**

**Agenda Item No. 1 : To discuss and approve specimen of Registration and Renewal Certificates.**

The Chair presented revised specimen of Registration and Renewal Certificates before the house for perusal and approval as per decision taken in the previous Council's meeting. **After examination, the House unanimously approved the revised specimen of both certificates and resolved that these should be printed from Pakistan Security Printing Press Islamabad with security code / features, having quantity of 25,000 of each certificate. The house also decided to issue a circular to the Principals and Members to submit cases of Registrations / Renewals with Demand Draft in lump sum instead of separate draft of each case.**



After discussion, the House authorized Homoeopathic Doctor Faisal Saleem, Chairman Registration, Renewal & Code of Ethic Committee to pursue the case on behalf of NCH.
