### AGENDA POINT NO. 1: TO CONFIRM MINUTES OF PREVIOUS 151<sup>ST</sup> ANNUAL (BUDGET) MEETING OF NCH HELD ON 28<sup>TH</sup> AND 29<sup>TH</sup> JUNE 2019.

The President presented first point of Agenda before the House. The Registrar stated that no objection letter was received from any member except Homoeopathic Doctor Ilahi Bux, which was read out before the House. At this juncture, Homoeopathic Doctor Javed Akhter said that he also seconded him. The chair overruled the objection of Homoeopathic Doctor Javed Akhter. However, view point of Homoeopathic Doctor Ilahi Bux on constitution of committee for coordination with NCT was accepted but the *House confirmed the minutes of previous 151<sup>st</sup> Annual (Budget) Meeting of NCH*.

## AGENDA POINT NO. 2: TO DISCUSS DRAFT MSDS OF SINDH HEALTHCARE COMMISSION CIRCULATED VIDE LETTER NO. NCH/F. 1-2 (SHC)/2019-4334 DATED 25<sup>TH</sup> APRIL 2019.

The President presented next agenda item before the House and stated that Draft of MSDS Sindh Healthcare Commission which have already been circulated amongst the members of the Council vide letter No. NCH/. 1-2 (SHC)/2019-4334 dated 25<sup>th</sup> April 2019. The members were requested to submit their comments within fortnight but the office has not received comments from any member of the Council. At this moment, the chair requested Homoeopathic Doctor Ilahi Bux to brief the house on the MSDS of Sindh Healthcare Commission. He briefed the house. Homoeopathic Doctor Saeed ur Rehman Khattak, Mr. Khalil Ahmed, Homoeopathic Doctor Siddique Ali Ansari, Homoeopathic Doctor Muhammad Aslam Khan, Homoeopathic Doctor Muhammad Irfan Wali, Homoeopathic Doctor Muhammad Aslam Khan, Homoeopathic Doctor Muhammad Irfan Wali, Homoeopathic Doctor Muhammad Moin Khan took-part in the discussion. After heated discussion, the House resolved as under:-

- i) To revisit of existing Code of Ethics by Act, Rules & Regulations Committee. The same may also be forwarded to the Federal Government for approval. Thereafter a meeting will be arranged with the Chief Executives of all 03 Healthcare Commissions i.e. Punjab, Sindh and Khyber Pakhtunkhwa.
- ii) A letter will be forwarded to all Healthcare Commissions regarding adoption of NCH Code of Ethics only.
- iii) NCH Representative must be present at the time of hearing of any case.

# AGENDA POINT NO. 3: TO DISCUSS LETTER DATED 14-04-2019 RECEIVED FROM HOMOEOPATHIC DOCTOR AKMAL KHAN (CHAKWAL) REGARDING USE OF HOMOEOPATHIC CAPSULES.

The President present next agenda point and read out letter dated 14-04-2019 of Homoeopathic Doctor Akmal Khan, Alam Memorial Clinic, Tamman, Tehsil Talagang, District Chakwal regarding prescription of Homoeopathic Capsules by a Registered Homoeopathic Practitioners. The said letter has already been circulated amongst Members of the Council vide letter dated 14<sup>th</sup> May 2019.

2. Homoeopathic Doctor Ilahi Bux supported the use and prescription of medicine through capsules. He suggested referring this issue to DRAP. Homoeopathic Doctor Waheed Ahmad stated that sealed packed capsules of different companies which are registered with DRAP are in the market. He also supported the use of capsules by Registered Medical Practitioners. Homoeopathic Doctor Naeem Hafeez and Homoeopathic Doctor Faisal Saleem opposed the use and prescription of medicines through capsules by Registered Homoeopathic Medical Practitioners. After discussion, the House referred the matter to Drug & Pharmacopoeia Committee for more examination and thereafter report of the committee will be placed in the next Council meeting.

# AGENDA POINT NO. 4: TO DISCUSS LETTER DATED 18-06-2019 OF FRONTIER HMC PESHAWAR REGARDING PERMISSION TO CONTINUE BHMS GRADED PROGRAM.

The President read out Frontier Homoeopathic Medical College Peshawar letter dated 18-06-2019 wherein Registrar of the institution requested that until the new program (3 Years) is accepted by HEC/University, the BHMS Graded Program (2 Years) should be allowed to function, as it would be impossible to enter the Homoeopathic program in a university, once it is decided to close the course.

- 2. Homoeopathic Doctor Saeed ur Rehman Khattak supported the view point of Frontier HMC Peshawar and stated the said program was started by the University after huge hard working and long efforts, therefore, decision of closing of 2 Years BHMS Graded Program may be reviewed.
- 3. Homoeopathic Doctor Javed Akhter, Homoeopathic Doctor Naeem Hafeez, Homoeopathic Doctor Ilahi Bux and Homoeopathic Doctor Aisha Nawaz were disagreed to restore 2 Years BHMS Graded Degree Program in existence of BHMS 5 Years Degree Program and DHMS 4 Years Diploma. Homoeopathic Doctor Rao Ghulam

Murtaza narrated the background of BHMS 5 Years Degree Program running in University College of Conventional Medicine (Islamia University Bahawalpur). He suggested to refer this matter to Syllabus Committee but Homoeopathic Doctor Saeed ur Rehman was disagreed with the proposal of the Vice President.

The Chair with the consent of House constituted following committee for the purpose:-

a) President NCH

- b) Vice President NCH
- c) Chairman Finance Committee Homoeopathic Doctor Saeed ur Rehman Khattak will also assist the committee.
- 2. The committee will arrange the meeting with the Vice Chancellor of the University as well as with the HEC.

### AGENDA POINT NO. 5: TO DISCUSS LETTERS OF FOLLOWING H.M. COLLEGES FOR RE-ALLOCATION OF SEATS:-

The President put up next agenda item and stated that letters for enhancement of allocated seats have been received from the following Homoeopathic Medical Colleges:-

- viii) THE HMC GUJRANWALA
- 2. The Chair requested the members of the Council to give consent on enhancement of allocated seats one by one. Homoeopathic Doctor Muhammad Irfan Wali suggested to increase allocated seats of H.M. Colleges after carrying proper inspection. Mr. Khalil Ahmed, Chairman Finance Committee agreed to enhance seats with strict conditions and availability of additional facilities. Homoeopathic Doctor Waheed Ahmad is of the view that seats may be increased with the surety of daily attendance of the students and availability of proper space. Homoeopathic Doctor Ilahi Bux stated that Pak. Central and Yasir Niaz H.M.Cs have good buildings so withat their

seats may be enhanced. However, majority of members of the House were disagreed to enhance allocated seats beyond 60:-

### DECISION:

After exhaustive discussion the House imposed following conditions for enhancement of allocated seats beyond 60:-

- a) Requirement of existing Yard Stick should be considered doubled in all respect i.e. building, laboratories, libraries, equipments and staff.
- b) Attendance of the students is mandatory as per request of the college management in all four classes.
- c) Surprise inspection shall be carried out by the local members in presence of President / Vice President or Chairman Inspection Committee. In case of failure in showing attendance of students, 2<sup>nd</sup> inspection will be conducted on payment of fee of Rs. 50,000/-.

AGENDA POINT NO. 6: TO DISCUSS PROPOSALS SUBMITTED BY HOMOEOPATHIC DOCTOR SAEED UR REHMAN KHATTAK AND HOMOEOPATHIC DOCTOR AISHA NAWAZ, MEMBER NCH FOR AWARD OF TITLE OF PROFESSORSHIP AS CIRCULATED VIDE LETTER NO. NCH/F. 11-16/2019-4612 DATED 30<sup>TH</sup> AUGUST 2019.

The Chair presented next agenda item and stated that proposals received from Homoeopathic Doctor Saeed ur Rehman Khattak and Aisha Nawaz for award of title of Professorship was already circulated amongst the members of the Council. # AGENDA POINT NO. 8: TO DISCUSS SINDH HEALTHCARE COMMISSION LETTER NO. 0598/SHCC/CEO DATED 30<sup>TH</sup> JULY 2019 REGARDING "ISSUES RELATED TO NCH FOR CLARIFICATIONS"

The President put up next agenda item and read out Sindh Healthcare Commission letter dated 30<sup>th</sup> July 2019 before the House. The Vice president also briefed the house about the discussion held during the meeting arranged by Sindh Healthcare Commission. <u>After discussion the House decided to forward proper reply to the Sindh Healthcare Commission accordingly.</u>

2. At this juncture. Homoeopathic Doctor Tabassum Hussain pointed out that Registration and Renewal Certificates are being received from the office through Post Office are not in good condition. These are wear and tear and folded while "Not to be Folded" is clearly mentioned on the top of the envelope. Mr. Khalil Ahmad, Chairman Finance Committee stated that we are bound to dispatch official mail through Pakistan Post Office as per instructions of the Federal Government. It was decided that file covers may be printed in the size of Registration / Renewals Certificates to avoid any loss.

## AGENDA POINT NO. 9: TO DISCUSS APPLICATION OF SYED FAKHAR UL HASSAN FOR APPOINTMENT AS MEDIA ADVISOR IN NCH

The President presented application submitted by Homoeopathic Doctor Syed Fakhar ul- Hassan S/o Syed Mehmood ul Hassan for appointment as Media Advisor in NCH. Homoeopathic Doctor Ilahi Bux and Mr. Khalil Ahmad stated that there is no provision is exists in the UAH Act / Rules for appointment of Media Advisor in NCH. Homoeopathic Doctor Ilahi Bux opposed his appointment as media advisor and commented that the creation of position for a person despite a purpose. After discussion the House decided to forward his application to the Ministry of National Health Services, Regulations for further consideration/appointment.

### AGENDA POINT NO. 10: TO DISCUSS:-

- i) Homoeopathic Doctor Muhammad Tariq Khan, Member NCH letter dated 15<sup>th</sup> July 2019 regarding suggestion for the up-gradation of DHMS and BHMS Education as circulated vide letter dated 29<sup>th</sup> July 2019.
- Homocopathic Doctor Muhammad Tariq Khan, Member NCH letter dated 20<sup>th</sup> July 2019 regarding Introduction of Faculty of Homocopathy UK to get its affiliation circulated vide letter dated 29<sup>th</sup> July 2019.

The President NCH invited Homoeopathic Doctor Muhammad Tariq Khan to brief the house. He briefed in detail. Homoeopathic Doctor Muhammad Moin Khan said that how many computers will be installed. Homoeopathic Doctor Saeed ur Rehman Khattak stated that is it demonstration is available. Homoeopathic Doctor Muhammad Tariq Khan replied that demo is available and can be checked / obtained through internet. Homoeopathic Doctor Ilahi Bux questioned that is it on line or off line. Homoeopathic Doctor Faisal Saleem opposed and stated that NCH should not be involved in these activities, if any person is desirous he will purchase at his own. Homoeopathic Doctor Javed Akhter supported the view point of Homoeopathic Doctor Tariq Khan. The Chair read out Section 24 of the Act and resolved that matter may be examined in the light of UAH ACT, 1965 and Rules/Regulations framed there-under.

iii) Restructuring of NCH Committees circulated vide letter dated 29<sup>th</sup> July 2019.

The House unanimously dissolved the sub-committees which was earlier constituted under section 14 (cc) of the UAH Act. 1965 during 149<sup>th</sup> (Regular) Meeting of NCH held on 27-29 December 2018, except the following. Remaining will be re-constituted later on:-

#### DECISION:

"It is reiterated that instructions of the Federal Government has already been circulated amongst the Homoeopathic Medical Colleges and practitioners for strict compliance. However, to control the practice/surgical interventions (major/minor), use of diagnostic techniques and prescriptions of allopathic medicines other than registered medical practitioners, NCH is going to appoint honorary District Registrars in all four provinces who will watch the activities of Homoeopathic Doctors with the approval of the Council"

## AGENDA POINT NO. 12: TO DISCUSS LETTER DATED 14-05-2019 OF HOMOEOPATHIC DOCTOR COL (RETD) IOBAL SHAHIN REGARDING "POLIO DILEMA – "HOMOEOPATHY, A GOOD OPTION"

The President put up next agenda item and read out letter of Homoeopathic Doctor Col. (Retd.) Iqbal Shahin before the House. <u>The house after discussion referred the matter to Drug and Pharmacopoeia Committee for examination and report. The committee further decided that working paper may be obtained from Col. (Retd.) Iqbal Shahin.</u>

### AGENDA POINT NO. 13: TO DISCUSS APPLICATION FOR RECOGNITION OF NEWLY ESTABLISHED SHIFA HMC SWAT.

The Secretary/Registrar informed the House that an application for recognition under Section 17 of the UAH Act, II of 1965 of newly established Shifa HMC Swat has been received with prescribed fee. He requested to constitute an inspection team so that inspection may be carried out. The House constituted inspection team comprising of Homoeopathic Doctor Muhammad Irfan Wali and Homoeopathic Doctor Saeed ur Rehman Khattak.

### AGENDA POINT NO. 14: TO DISCUSS REPLIES OF SHOW CAUSES NOTICES OF 05 H.M. COLLEGES.

The President put up next agenda point and stated that as per decision of the Council, the office issued show causes notices to the following H.M. Colleges. He stated that replies of show cause notices have been received, which were read out one by one before the House. After detailed discussion the house resolved as under:

#### a) Al-Sehat HMC Faisalabad (Dr. Shakoor)

The House accepted reply of show cause notice submitted by the Principal and decided to re-inspect the college within next 03 months.

#### b) Alavi HMC Karachi

The House accepted reply of show cause notice submitted by the Principal and decided to re-inspect the college within next 03 months.

### c) Dr. Hamid Memorial HMC Lahore

The House declared reply of show cause notice unsatisfactory and recommended for withdrawal of recognition under Section 19 of the UAH Act, II of 1965 because so many opportunities were provided to the management of the college to make up the deficiencies, but the management has badly failed to come up the minimum requirements of the Yard Stick.

### d) Pakistan HMC Lahore (DHMS & BHMS)

The House declared reply of show cause notices unsatisfactory and recommended for withdrawal of recognition under Section 19 of the UAH Act, II of 1965 of both colleges (DHMS & BHMS) because so many opportunities were provided to the management of the college to make up the deficiencies, but the management has badly failed to come up the minimum requirements of the Yard Stick.

#### e) Attba HMC Jauharabad

The House declared reply of show cause notice unsatisfactory and recommended for withdrawal of recognition under Section 19 of the UAH Act, II of 1965 because so many opportunities were provided to the management of the college to make up the deficiencies, but the management has badly failed to come up the minimum requirements of the Yard Stick.

#### f) Ashraf HMC Lahore

The House accepted reply of show cause notice submitted by the Principal and decided to re-inspect the college within next 03 months through an inspection team comprising of Homoeopathic Doctor Tabassum Hussain and Siddique Ali Anasri, Member of NCH.

AGENDA POINT NO. 15: TO DISCUSS MATTER REGARDING CANCELLATION OF REGISTRATION OF HOMOEOPATHIC DOCTOR MAHMOONA NOOR, EX-PRINCIPAL AL-FALAH HMC TOBA TEK SINGH.

The President presented next point of agenda and briefed the House. He also read out complaints received from Mr. Akhtar Abbas resident of Toba Tek Singh against her previous and present Secondary School Certificate. On receipt of complaint MS Mahmoona Noor was provided numbers of opportunities to clear her position about her Secondary School Certificate. A show cause notice was also issued to him during the tenure of Administrator but she failed to attend the office. The complainant has also filed a similar complaint in office of the FIA Faisalabad. FIA also summoned the Registrar NCH in his office at Faisalabad. He appeared and briefed accordingly. After discussion and consideration all aspects of the matter, the House decided to cancel Registration, Renewal and DHMS of MS Mahmoona Noor, ex-Principal of Al-Falah HMC Toba Tek Singh under intimation to the FIA Faisalabad and complainant.

## AGENDA POINT NO. 16: TO DISCUSS MATTER REGARDING CANCELLATION OF REGISTRATION OF HOMOEOPATHIC DOCTOR UZMA GHANI

Registrar / Secretary informed the House that a complaint dated 13-06-2019 was received from Homoeopathic Doctor Faisal Saleem with solid proof that MS Uzma Ghani passed her matriculation examinations with Arts subjects. She enrolled / passed her DHMS after tampering matriculation certificate from Arts to Science Group and succeeded to get registration certificate No. 145028 on 03-04-2015 from the office of NCH. She was called for personal hearing on 10<sup>th</sup> July 2019 and 12<sup>th</sup> September 2019 respectively but she failed to do so. Finally she was advised vide letter dated 19-09-2019 "to send a photo copy of matriculation certificate duly attested by a gazetted officer within 15 days of receipt of this letter. In case of failure, ex-party proceedings will be initiated." But as yet she has not provided the same. The House decided unanimously to cancel her DHMS and Registration under section 28 of UAH Act, II of 1965.

## AGENDA POINT NO. 17: TO DISCUSS MATTER REGARDING CANCELLATION OF REGISTRATION OF HOMOEOPATHIC DOCTOR SADAQAT ALI KHAN BALOCH (FAISALABAD).

The President stated that a complaint was received against Homoeopathic Doctor Sadaqat Ali Khan regarding his illegal practice and involvement in unethical advertisements in electronic media in violation of UAH Act, 1965 and approved Code of Ethics. He was called for personal hearing on 10<sup>th</sup> July 2019 for explanation but he failed to satisfy the committee. The House decided to issue show cause notice to Homoeopathic Doctor Sadaqat Ali Khan before cancellation of his registration under Section 28 of the Act.

## AGENDA POINT NO. 18: TO DISCUSS MATTER REGARDING CANCELLATION OF REGISTRATION OF HOMOEOPATHIC DOCTOR SHAHID QAMAR SARDAR, PRINCIPAL PUNJAB SARHAD HMC BHAKKUR.

The committee further decided to issue explanation letter to the Principal Punjab Sarhad HMC Bhakkar in this regard. Reply of explanation letter has been received from the Principal on 11-09-2019, which was read out before the House. The House after consideration of his reply decided to issue warning letter with direction to be careful in future.
