- Homoeopathic Doctor Muhammad Aslam Khan and Homoeopathic Doctor Muhammad Asif Khan did not attend the meeting due to their pre-engagements.
- 2. Meeting started at 11.00 AM. Homoeopathic Doctor Waheed Ahmad recited verses from the "HOLY QURAN". Homoeopathic Doctor Siddique Ali Ansari offered Na'at Sharif. The meeting was chaired by the President Homoeopathic Doctor Mahmood ul Haq Abbasi. He welcomed all the members for their participation in the meeting.

#### OFFICE POINTS

Agenda Jean Jo. 1. To review see and Re juid Budget 7- limates for he FY 267-20 and Budget Estimates for the FY 2020-21 circulated on WhatsApp on 2 h / 30th June 2020 evening in the light of recommendations of Finance Countified NCH.

The President put the first agenda item before the to see for discussion. On a point of order Homogopathic Locker M.S. Fawed Awan stated that a per Used Act and Roles /

Regulations framed there under, 155<sup>th</sup> meeting was not called properly as required vide NCH Regulation 4 & 5 of NCH (Holding of Meeting) Regulations 1990, because no Notice of meeting was issued to the members, therefore the meeting is treated as being void ab initio. He suggested the Chairman Finance Committee to make request this august house for condone of this lacuna. At this juncture, the President stated that due to Covid-19, the said meeting was called in an emergency keeping in view of Rule 9 of NCH (Administration and Financial Management Rules 2008..... Preparation of annual budget. Object head-wise Budget Estimates of "Receipts" and "Expenditure" duly prepared for the next financial year shall be placed, for approval, in a meeting of the Council to be held any time before the close of current financial year." The President invited Chairman Finance Committee to further brief the house about the meeting. The Chairman Finance Committee referred the above Rule and informed different ways of meeting. He stated that the said meeting was convened in an emergency due to Covid-19 and shortage of time through WhatsApp circulation in member's official group. He also added that the Senate, National Assembly and Cabinet were also summoned through circulation, hence, the way adopted for that meeting is effective and according to law. He also briefed the house on the Budget Estimates for the FY 2020-21 and explained the increase budget allocation of different heads.

- 2. Homoeopathic Doctor M.B. Jawed Awan pointed out that amount allocated in the head of Civil Works (Building & Structures) is meager and suggested to increase. He proposed to construct afloor on the existing Council's building. He further said that consequent upon discontinuation of Grant-in-Aid to Homoeopathic Medical Colleges by the Ministry, it is necessary to sanction grant in aid from the own sources of the Council in order to have better control of institutions. He was also of the view that a sufficient fund is available with the Council so increase allocation of this head upto 10 million. The Council may write a letter to the Ministry for allocating grant in aid to Homoeopathic Medical Colleges for construction of their buildings. He appreciated the work of Chairman Finance Committee.
- 3. Mr. Khalil Ahmad, Chairman Finance Committee agreed with the view point of Homoeopathic Doctor M.B. Jawed Awan. He stated that grant-in-aid be given to the Homoeopathic Medical Colleges but on the basis of performance, first of all we have to develop a plan for up-gradation of institutions and formulate parameters / SOPs in this regard.
- 4. Homoeopathic Doctor Javed Akhter supported the view point and stated that almost all colleges are deficient and without 5 bedded hospital, medicines and dispensary. Amount may be allocated to H.M. Colleges only for improvement of Dispensary and procuring the medicines.
- 5. Homoeopathic Doctor Tariq Khan suggested to nominate homoeopathic medical colleges for rantine the
- Homoeopathic Doctor Ilahi Bux questioned the chair about availability of any rider in law for prevision of funds to Homoeopathic Medical Colleges are further stated that at the time of inspection we usually ask for audit report of the college rather to check their expenditure and income. The chair replied that presently no provision is available in NCH rules/regulations to provide funds to HMCs.

- 7. Homoeopathic Doctor Naeem Hafeez seconded the view point of Dr. M.B. Jawed Awan and requested the House to release funds to HMCs from funds of NCH and honorarium may be fixed for Members of the Council. He further said that in view of Covid-19, examination fee of students payable to Council should be waived.
- 8. Homoeopathic Doctor Saeed ur Rehman Khattak said that examination, registration and renewal fees etc., have been enhanced in 2018 but remuneration of assessment of answer scripts, paper setters and moderators is meager, it should be revised. He said that due to inadequacy in payment the examiners avoid to pay full attention. The Secretary clarified the position and informed that fee structure as laid down in UAH System of Medicines Rules 1980 was revised. While the Fee given in the Examinations Regulations is still remain unchanged. Dr. Saeed ur Rehman Khattak requested the House to ask the Federal Government for enhancement of such fees.
- 9. Homoeopathic Doctor Siddique Ali Ansari said that different cases against NCH are pending in the courts. He suggested increasing the allocation of amount in the head of litigation expenses. The Chairman Finance Committee replied that sufficient amount is available in this head. However, amount of any head may be enhanced through re-appropriation as and when required.
- 10. Homoeopathic Doctor Muhammad Irfan Wali stated that remuneration bills of inspectors appointed by NCH during March Test 2019 are still unpaid, while this year students have been promoted on the basis of their result of March Test. President stated that inspectors were appointed legally in accordance with Section 18 of the UAH Act II of 1965 but unfortunately the Ministry of NHSR&C rejected the case. The Secretary / Registrar informed the house that the Competent Authority of Ministry of NHSR&C vide letter dated 29<sup>th</sup> January 2020 has rejected the claims of NCH for payment to inspectors who did perform duties during March test on the ground that the Council is authorized to appoint Inspectors only for the conduct of qualifying examination which is held at least once in every year for the purpose of granting a diploma conferring the right of registration under the said Act. Furthermore, in the light of Regulation 23(2) of the Homoeopathic Examination Regulation, 1986, March Test which determine the eligibility of a candidate to appear in the qualifying/annual examination, shall be held by the college concerned.
- 11. Homoeopathic Doctor Rao Ghulam Murtaza said that the House re-recommend the case for payment of bills to inspectors. The House decided to re-submit the case to the Ministry for approval.
- Homoeopathic Doctor Ilahi Bux referred his agenda item regarding privileges of the President, Vice President and Members of the Council. He proposed some amendments in NCH (Administration & Financial) Management Rules 2008 and presented a draft before the house. The Plause constituted a committee constitute of 11 mocepathic Poctor 12 B standed Awan, Homocopathic Doctor Ilahi Bux and Chairman Linance Committee. The solid draft was referred to the same committee for examination and amendments as and where required. The house further decided that the same committee will also frame the OFT regarding award of Gran-in-Aid to the Homosopa hie Medical Colleges from NCH funds.

The committee shall submit his report within one month. Budget allocation of this head will be reviewed on receipt of SOPs.

- Homoeopathic Doctor Saeed ur Rehman Khattak referred Rule 9(4) of UAH System of Medicines Rules 1980 and said that the colleges have no resources to purchase land for their own building, so the Council make a request to the Federal Government for waiving off this provision. The President informed that the Council has already requested the Ministry for deletion of the said Rule on the recommendations of the Council.
- 14. Homoeopathic Doctor Rao Ghulam Murtaza said that the existing building of the Council may be renovated so the office appearance should become like an office and any visitor or Homoeopathic Practitioner feels honour while visiting. At present the office is comprised of two big halls and doesn't look like generally accepted impression. The Chairman Finance Committee and Homoeopathic Doctor Waheed Ahmad seconded him.
- Homoeopathic Doctor Jawed Akhter said to purchase a plot in Islamabad. Present office 15. located in the Punjab province. The building is without plot id so the expenses may cause waste of fund.
- 16. The Chair informed the House that the case regarding purchase of present building is under investigation in FIA Islamabad. However, it was decided to pursue the case in FIA and present building may be renovated as well.

#### Decision:

After detailed discussion, the House unanimously approved the minutes of 155th Meeting of the Council held on 29th and 30th June 2020 regarding Budget Estimates of the Council for next Financial Year 2020-21.

The President read out inquiry report received vide Ministry's letter No. F-8-4/2019-Estab-II dated 10<sup>th</sup> December 2019 before the house. The chair further requested the Registrar to more brief the house as he was a part of the said inquiry committee. He did accordingly.

- 2. Homoeopathic Doctor Ilahi Bux, Rao Ghulam Murtaza, Vice President, Saeed ur Rehman Khattak, Siddique Ali Ansari, M.B. Jawed Awan took-part in the discussion.
- 3. Homoeopathic Doctor Javed Akhter and Homoeopathic Doctor Tariq Khan endorsed the recommendations of the inquiry committee to extend the lease agreement to save the Council from bearing further loss, loss of time and effort to get the building vacated in an amicable way. Legal battle will prolong and desired goal may not be achieved in this way.
- 4. The chair with the consent of the House constituted a committee comprising of Homoeopathic Doctor Ilahi Bux, M.B. Jawed Awan and Saeed ur Rehman Khattak to look into the matter and cobmit draft reply tomorrow session for onward submission to the Ministry. The house also resolved to make a request in writing to the Ministry to provide complete inquiry report for detail examination.

- 2. Meeting started at 11.00 AM. Homoeopathic Doctor M.B. Jawed Awan recited verses from the "HOLY QURAN and also offered Na'at Sharif. The meeting chaired by the President-Homoeopathic Doctor Mahmood ul Haq Abbasi. He welcomed all the members for their participation in the meeting.

# Agenda Item No. 4: To discuss Report received from Committee constituted for AJK Council for registration of students with NCH

The Chair put up next point a limited lie reportalic Doctor M.B. Jawed Awen to lead out the report before the House. He read out the report and stated that AJK Council has been established on the ground floor of the building. Homoeopathic Medical College owned by Homoeopathic Doctor Rafaqat Ch. The building of the Council and college is the same. The room of the Principal is being used as office of the President, in other room the Registrar was sitting and in other small room a computer operator was sitting.

- 2. Homoeopathic Doctor Ilahi Bux said whether we are authorized to check any Council outside the country because AJK is an independent state. NCH Pakistan cannot allow to any practitioner to practice in Pakistan who have passed his DHMS from AJK.
- 3. Homoeopathic Doctor Rao Ghulam Murtaza, Vice President said that Medical College and Nursing College are functioning in AJK are duly registered with PMDC and Nursing Council respectively. 02 Homoeopathic Medical Colleges are running in AJK, one in Mirpur and other in Rawalakot. The Council is divided in two parts. 80% students are being enrolled from the province of Punjab. Some persons are double registered with NCH Pakistan and AJK. At this stage the President informed that at present the AJK Council has been dissolved and Administrator is appointed.
- 4. Homoeopathic Doctor Ilahi Bux suggested that registrations of the practitioners registered with both Councils may be cancelled because the institutions of AJK are not affiliated with NCH Pakistan. The President read out Section 24 (3) in this regard before the house.

The Council is refused to consider the matter of registration in view of different criteria of admission in DHMS students of Pakistan Council.\*\*

# Agenda Item No. 5: To discuss The Islamia University of Bahawalpur letter No. 1089/AFF dated 26-12-2019 regarding affiliation of Pakistan HMC for BHMS Degree Program.

The President put up next agenda item and briefed the House also read out NCH letter dated 7<sup>th</sup> October 2019 addressed to the Registrar of the Islamia University of Bahawalpur and its reply received from the Deputy Registrar (Affiliation) before the House.

- 2. Homoeopathic Doctor IIahi Bux said the he inspected the Pakistan HMC Lahore and pointed out deficiencies. The management promised that they will remove all deficiencies as they have already purchased land for college building.
- The President said that no registration should be issued to BHMS students, passed from Pakistan HMC Lahore as standard of education is not secure in the said college and Council has already been forwarded his case for withdrawal of recognition of degree program. Homoeopathic Doctor Tariq Khan disagreed to send letter to the University.
- The Vice President said that in the light of SOP received from the Islamia University of Benavalour Coursell should send a copy of Yard Stick for reconsideration. Dr. Faisal Selection seconded him.

- 5. Homoeopathic Doctor Javed Akhter said we should require to adopt equal criteria during the inspection of H.M. Colleges. Mostly colleges have not updated Registration Certificates of their Societies and running the business illegally. He disagreed to send the letter to the University.
- 6. Homoeopathic Doctor M.B. Jawed Awan said that NCH is the representatives of all colleges, and treated them our own. He said that he has also inspected University College of Conventional Medicines Bahawalpur running under the umbrella of the Islamia University of Bahawalpur, where standard of education is also not secured. The Laboratory and Library were deficient and not fulfilled the basic requirement. In the past Pakistan HMC Lahore was a very good college but after change of management the same is in bad condition. The Council members not give report on political basis they give report only they observed during inspection of any institution.
- 7. Homoeopathic Doctor Saeed ur Rehman Khattak said if the Islamia University of Bahawalpur does not consider the report of NCH, how can this Council consider the report of the University. In this regard, Council has to write a letter to Islama University of Bahawalpur again in the light of NCH inspection report.

Letter may be forwarded to the University for Re-considering the affiliation as the college does not meet the requirement of Yard Stick as transpires Inspection Report of NCH. The Council has already recommended the college (BHMS&DHMS) for de-recognition. Hence the University stops examination of college from next session.

## Agenda Item No. 6: To discuss request of the Principal Al-Falah HMC Toba Tek Singh for change of building.

The Chair read out letter No. Alfalah-Q403/20 dated 4<sup>th</sup> February 2020 received from the Principal Al-Falah HMC Toba Tek Singh regarding change of building. After discussion the House constituted from Inspection Team for inspection of proposed building situated at Rural Area Chak No. 295 GB Tehsil & District Toba Tek Singh:-

# Agenda Item No. 7: To discuss request of the Principal Dr. Hamid HMC Lahore regarding de-recognition of college.

The chair presented next agenda point, briefed the house about the background of the case and read out letter dated -07 2020 received from the College. He said that the Council has already forwarded a letter to t - Ministry for withdrawal of recognition. He equested the house to decide it.

- 2. Homoeopathic Doctor Faisal Saleem said that Council should withdraw his letter if the college meets the requirement of Yard Stick.
- 3. Homoeopathic Doctor Ilahi Bux said decision of withdrawal of recognition is not appropriate in the light of few removable deficiencies.
- 4. Homoeopathic Doctor Saeed ur Rehman Khattak if the college has removed all deficiencies then the Council may re-inspect at the admissible expenses.
  - 5. Homoeopathic Doctor Javed Akhter said that de-recognition letter may be withdrawn after inspection by the Council.
  - 6. Homoeopathic Doctor Tabassum Hussain, Naeem Hafeez, Waheed Ahmad, Muhammad Irfan Wali suggested to re-inspect the college before withdrawal of letter from the ministry.
  - 7. The Vice President said that letter may be withdrawn subject to satisfactory report of inspection team.

The Council considered the request of Principal, Dr. Hamid HMC Lahore and decided that letter regarding withdrawal of recognition (already forwarded to the Ministry) may be reverted subject to positive report of inspection. The House constituted following inspection team:-

Agenda Item No. 8: To discuss cancellation of registration of Homoeopathic Doctor Muhammad Waqas Azam (Mansehra) and Homoeopathic Doctor Sadaqat Ali Baloch (Faisalabad).

The Chair put up next agenda item and presented case of Homoeopathic Doctor Muhammad Waqas Azam (Mansehra) and Homoeopathic Doctor Sadaqat Ali Khan Baloch (Faisalabad) for cancellation of registration as all the Codal formalities have been completed.

a) Homocopathic Doctor Muhammad Waqas Azam

Homeopathic Doctor Faisal Saleem read out the inspection report of his clinic and briefed the house. He stated that all allegations leveled by the complainant are true and proved. He recommonded to cancel his registration.

- 3) Homoeopathic Doctor Saeed ur Rehman Khattak said that we are to facilitate the Homoeopathic Practitioner but if the practitioner violates the code of ethics then the Council should take action according to the provisions of the Act.
- 4) Homoeopathic Doctor Ilahi Bux said that instead of cancellation of registration it may be suspended for the time being till such time he follow the code of ethics. Practitioners are unaware about the code of ethics and for their awareness a copy of same should be provided to them with registration or renewal certificate.
- 5) Homoeopathic Doctor Muhammad Irfan Wali said SOPs may be framed in the light of UAH Act, 1965 and provide to the practitioner at the time of registration and renewal.

The House after taking all aspects of the matter into consideration, decided to cancel registration and renewal of Homoeopathic Doctor Muhammad Waqas Azam as he is involved in un-ethical practice. However, he m right to file appeal before the Council.

b) Homoeopathic Doctor Sadaqat Ali Khan Baloch (Faisalabad)

The President briefed the house about the background of the case. He stated that Mr. Sadaqat Ali Khan Baloch was called for hearing in person but he failed to satisfyme. Homoeopathic Doctor Faisal Saleem informed that the practitioner also offer sweetenerto him

#### Decision:

The House after taking all aspects of the matter into consideration, decided to cancel registration and renewal of Homoeopathic Doctor Sadaqat Ali Khan Baloch as he is involved in un-ethical practice. However, he has right to file appeal before the Council.

### Agenda Item No. 9: To discuss reply of show cause notice received from the Principal Shah Latif HMC Karachi.

The President read out reply of show cause notice, bearing No BHMC/Ins/2019-16 dated 14-07-2020 received from the Principal Shah Abdul Latif Bhitai Homoeopathic Medical College Karachi before the house.

- ... Homoe spainic Doctor Fariq Khai, said that repty of the Principal is totally fabricated to was informed the factual situation at the time of the inspection.
- Hemosopathic Doctor Javed Akhter said that a local member may be deputed to reinspect the college?
  - 4 Homoeopathic Doctor Muhammad Idrees showed as disagreed about re-inspection of the institution.

- 5. Homoeopathic Doctor Saeed ur Rehman Khattak said that according to reply he did not accepted the deficiencies pointed out by the inspection team.
- 6. Homoeopathic Doctor M.B. Jawed Awan proposed to declare reply unsatisfactory and proceed further as per UAH Act.
- 7. Homoeopathic Doctor Siddique Ali Ansari said that the college is sub-standard and a school is running in the college building. There is no arrangement of classes, only fee is being received from the students and conducted examinations forthwith. The Council should take strict action against the said institution.

The reply of the Principal of the college was declared unsatisfactory and decided for de-recognition of Shah Abdul Latif Bhitai HMC Karachi under Section 19 of the UAH Act, 1965.

# Agenda Item No. 10: To confirm Minutes of Meeting of Tender Opening Committee held on 29th June 2020.

President put up next agenda item and said that a meeting of the Tender Opening Committee was held on 29<sup>th</sup> June 2020 in connection with opening of tender of different items including development and installation of software. Tenders of other items were accepted by the committee except the software. All tenders received for software were over one hundred million to three hundred million rupees. Chairman Finance Committee was also invited in the said meeting as technical expert. After examination of all tenders, the committee decided that task of development and installation of software will be re-tendered after preparing the Tender Document (TD) carefully besides the followings:-

- a) Hiring of consultant before publication of tender.
- b) Creation of one post of IT administrator.
- c) Framing of terms & conditions for biding pre-qualifications.
- 2. Homoeopathic Doctor Ilahi Bux said that we should consult concerned department of the Government for the purpose.
- 3. Homocopathic Doctor Saeed ur Rehman Khaitak said that I have already prepared working paper on the T. He suggeste 'hising at IT Consultant to finelize it
- 4. Homoeopathic Doctor Tariq Khan said that hiring of consultant is very necessary for e-office of the Council.

The House approved minutes and granted approval for hiring of I.T. consultant and creation of one post of IT Admin as recommended by the committee.

# Agenda Item No. 11: To confirm Minutes of Inspection and Finance Committee meetings held 10<sup>th</sup> August 2020.

The President informed the House that meeting of the Inspection Committee was held yesterday. He read out minutes of the said committee meeting before the house, which were confirmed with vote of decent by Homoeopathic Doctor Ilahi Bux and Javed Akhter.

2. The President also presented minutes of the meeting of the Finance Committee held on 10<sup>th</sup> August 2020, which were confirmed by the house.

Remaining Discussion -Agenda Item No. 3: To discuss Ministry of NHSR&C letter No. F. 8-4/2019-Estab-II dated 10<sup>th</sup> December 2019 - Inquiry Report on irregular Leasing of NCH Building at Karachi.

The chair invited Homoeopathic Doctor M.B. Jawed Awan, member of the committee constituted yesterday for the purpose to convey the decisions recommended by the committee to the house. He informed the house that report has been finalized and will be read out by Homoeopathic Doctor Ilahi Bux. He read out the report of the committee as under:-

"After perusal of the official record regarding the matter the recommendations of the committee are as under:-

- As matter is subjuiced before the court of law and unless and until it is not finalized in either way we cannot proceed further with execution of fresh agreement.
- Even otherwise if suggestions conveyed by the Ministry vide letter No. F. 8-4/2019-ESTB-II dated 10-12-2019 acknowledged and acted upon there would be no guaranty/for peaceful handing over of the building by tenant to this Council. Because the suppose after the expiry of the "proposed fresh agreement" the transferil to reacate the said building again. We will be not be able to get possession forcibly and without due process of law and in said eventually we will have to file the fresh ejectment petition again. Hence execution of the fresh agreement as you suggested is not feasible. The opinion is being made after consultation with the legal experts.

3) The committee has suggested to advise the respective counsel representing ejectment case to file a fresh application for the withdrawal of the rent deposited by the tenant in the court of rent controller.

- The then President Homoeopthic Doctor Nasir Ahmad Ch. and associates may be served show cause notice as well as explanation letters requiring them immediately to deposit the amount accumulated as monetary loss accrued to the exchequer of the Council by way of:
  - i) The upper portion as advertised was to be rented out but despite the said whole building was handed over. The rent was for Rs. 40,000/-for the upper portion of the building while the remaining portion was also handed over without any reason and rent. The office should calculate the total amount rest from the inception of the agreement till the date including consecutive rise of rent as per agreement. The deficit amount may be recovered accordingly.
  - ii) No negotiation offer regarding renewal of revision of agreement/rent was initiated by the tenant/lessee.
  - The proceedings for the misconduct and proceeding for recovery of compensatory damages may be initiated against the agreement signatories, vis., the then President Homoeopathic Doctor Nasir Ahmad Ch, the then Registrar Homoeopathic Doctor Muhammad Ismail, Homoeopathic Doctor Junaid Akhter Bukhari then Member NCH and associates.
  - iv) All the lawful actions may be initiated as the admissible under the rules."
- 2. Mr. Khalil Ahmad, Chairman Finance Committee disagreed with the above report and said that we should extend the agreement and should not vacate the building by litigation in any way.

#### Decision:-

The house approved the above report except Chairman Finance Committee. The House also resolved that Registrar Mr. Aamir Nadeem Ramay is fully authorized to look after all the legal affairs of the Council's property/premises bearing Plot No. B/1, Street No. 2, situated at Block-7, Gulshan-e-Iqbal, Near Faran Club, Karachi measuring 1052 Sq. Yards, presently and in future as we'll and also seek all the remedies to vacate the said property.

# Agenda Item No. 12: To discuss complaints of Homoeopathic Doctor Javed Akhter, Member NCH on PMDU as well as electronic media.

President presented next agenda item and informed the house that being the member of this august house Homoeopathic Doctor Javed Akhter blamed the Council as well as Homoeopathic System of Medicine in the electronic, print media and PMDU. He read out his all complaints filed in the Ministry and PMDU before the house. He invited all members of the house to visit the office of the NCH and to check everything. He referred the show cause notices served to him by the ministry and their results. The honourable member was required to place the issues before this house before taken-up with the higher authorities.

- 2. Homoeopathic Doctor Ilahi Bux said that he feels the Council is not treating equally then ominated members and a covered up discriminative behavior with nominated members is an untold fact. The opinion of the nominated members is usually ignored and rejected with majority. Hence, they contacted with the Secretary Health.
- 2. Homoeopathic Doctor M.B. Jawed Awan proposed to constitute a 3 members committee (Two from nominated and one from elected members) to probe the allegations leveled by the member.
- 3. Homoeopathic Doctor Muhammad Irfan Wali said the complainant should prove the allegations of corruption. He threatened and warned to Homoeopathic Doctor Javed Akhter on preparation of Video of his college during the course of DHMS Annual examinations 2019.
- 4. Homoeopathic Doctor Saeed ur Rehman Khattak said that there is no discrimination between nominated and elected members in UAH Act, 1965 but elected members are representative of Homoeopaths and answerable to them. The complainants were required to submit their grievances in the NCH office firstly. They should not by pass the norms/procedure in any way. He always worked for betterment of profession. He said that personal attack should not be leveled without any solid proof. He further said that he visited Murree at his own expense and no expenditure of the Council was involved on his tour. He presented himself for audit. Any Pakistani can contest the election under Section 5 of the Act. There is no provision is available first coilege of members are represented to the Federal Government but not notified as yet. An inquiry may be conducted and if any the found corrupt then he will resign from the membership of the Council.
- is a responsible but his attitude is not good. He always leveled allegations only on WhatsApp group he never discussed these allegations in the meetings. He should avoid to be personalized. He

abused me in WhatsApp Group. He should withdraw his allegations otherwise house should take action against him.

- 6. Homoeopathic Doctor Tabassum Hussain said that we are equal and we should require to respect each other.
- 7. Homoeopathic Doctor Irum Naz Akhter said application to the Secretary is our basic wright.
  - 8. Homoeopathic Doctor Aisha Nawaz said that we are newly nominated members and were unaware about the procedure.
  - 9. Homoeopathic Doctor Tariq Khan said that this environment is not fruitful. This incident may not occur in future. Complaints are not uploaded on PMDU portal. We are required to work together for promotion of Homoeopathy.
  - 10. Homoeopathic Doctor Muhammad Idrees admitted that he has signed the complaint and assured that in future all matters will be placed before the house.
- 11. The Vice President explained the case of Al-Qamar HMC Multan and said that we are all equal status so work together for the system.
- 12. The President stated that he is member of this Council since 2001 and my assets are the same as in 2001 even after 19 years. The chair requested Homoeopathic Doctor Javed Akhter to explain his position.
- 13. The Chairman Finance Committee show serious concerns on the statement of Homoeopathic Doctor Muhammad Irfan Wali and requested Homoeopathic Doctor Javed Akhter to withdraw his all complaints.
- 13. Homoeopathic Doctor Javed Akhter satisfied after debate in the Council. He clarified his position, regretted from the house and assured that he will withdraw all such complaints filed in the Ministry and PMDU Portal in the best interest of the system. In future all matter will be placed before the Council according to oath taken as member of the Council.

#### Decision:

The House resolved that Homoeopathic Doctor Javed Akhter will withdraw all complaint /applications from the Ministry and PMD Pertal immediately.

2. The Secretary also informed that at present all posts are filled-in except 02 posts of Assistant, 01 post of LDC and 01 post of Naib Qasid. One female employee is working as Stenotypist from Sindh province. The post of LDC is against 6% quota of Balochistan Provence and Naib Qasid is on local basis which have already been advertised in the newspapers. One post of Assistant against Sindh quota will be filled-in after notification of the Selection Committee by the Federal Government. Homoeopathic Doctor Ilahi Bux was satisfied after briefing by the Secretary.

- 3. The Secretary also put up the matter of already approved Selection Committee and stated that applications have been received for appointment of one LDC against Balochistan quota and one Naib Qasid on local basis. As per instructions issued by the Prime Minister Office Islamabad vide letter No. DS (PMDU)/TAG-II-Institutional/19 dated 20th May 2020, new timelines for filling of vacant positions is 25<sup>th</sup> August 2020 and according to Recruitment Policy issued by the Federal Government dated 22<sup>nd</sup> October 2014, recruitment against vacant posts should be finalized within 120 days after advertisement. The Federal Government is pressing hard for filling of one post of LDC against Baluchistan quota.
- 2. Homoeopathic Doctor Ilahi Bux raised his reservations on the existing Selection Committee approved by the Federal Government vide letter dated 29<sup>th</sup> January 2020 and stated that the Federal Government did not consider the Section 14 (cc) of the UAH Act, II of 1965 while constitution of the committee. The President stated that office requested the Ministry in this regard and reply has been received from the Ministry, which was read out before the House. Homoeopathic Doctor Ilahi Bux proposed that the House should re-constitute selection committees for BPS 1-10 and 11-17 in according with Section 14 (cc) of the Act. The chair read out letter of Homoeopathic Doctor InamUllah Mirza, ex-President NCH before the house.

- 2. Homoeopathic Doctor Saeed ur Rehman Khattak opposed the enlistment of combination and proposed that the office may write a letter to DRAP in the light of Homoeopathic Pharmacopoeia.
- 3. Homoeopathic Doctor Ilahi Bux said that as per para 1 (2) of the Notification of DRAP, Pharmaceutical Companies will have to give the sale evidences / documents for last 10 years. Homoeopathic Doctor Saeed ur Rehman Khattak did not agreed with Dr. Ilahi Bux.
- 4. Homoeopathic Doctor M.B. Jawed Awan said that there is no concept of combination in Homoeopathy. Council should oppose the Notification of DRAP.
- 5. Homoeopathic Doctor Tariq Khan briefed the house regarding policy of DRAP in this regard. Combination may be allowed after trail. Consent of the Council for this purpose is necessary.
- 6. The President stated that there is no criteria available in the world as mentioned in para 1 (2) of the DRAP Notification.
- 7. Homoeopathic Doctor Irum Naz Akhter said that procedure of trail should be adopted.

# REMAING DISCUSSION REGARDING PRIVILEGES OF THE PRESIDENT, VICE PRESIDENT AND MEMBERS OF THE COUNCIL (PARA 12 OF AGENDA ITEM NO. 1)

The chair stated that yesterday a committee was constituted to propose privileges for the President and Members of the Council. He briefed the house about the case of TA/DA of NCH members, which was filed by Homoeopathic Doctor Khalid Mahmood, ex-member NCH before the Wafaqi Mohtasib Islamabad in previous tenure for grant of BPS-22 to the President and BPS-21 to the Members of the Council. He also read out findings of the Wafaqi Mohtasib and Director Legal, Aiwan-e-Sadar, Islamabad. He invited Homoeopathic Doctor Ilahi Bux to submit the proposal. He presented a draft amendment bill in NCH (Administration and Financial Management) Rules, 2008, which is attached as per Annex "A" to these minutes. According to this Bill, he proposed following privileges for the President and Members:-

- 4. The Chair informed that SSC verification is required only for fresh registration and first time of renewal.

#### Decision:

After discussion the House resolved that:-

- a) SSC verification from the concerned Boards for initial registration of all persons and first time renewal of those practitioners who have enrolled during the session 2003-04 and onwards is mandatory.
- b) Condition of verification of SSC on second time of renewal is removed.
- 2. It was further resolved that examination must be held in this year and 4<sup>th</sup> year students exempted from house job training only for this year due to Covid-19. A letter may be sent to the colleges.

#### AMENDMENT IN YARD STICK.

The chair read out para 2 a & b of the application for recognition of intuition regarding Governing Body and registration of Society under Society Registration Act 1860 and proposed to amend the said regulation with adding societies registered other than Society Registration Act 1860 like SECP etc. After discussion the house referred the matter to Act, Rules & Regulations Committee for detail examination and report.

### AGENDA ITEM NO. 1 OF HOMOEOPATHIC DOCTOR TARIO KHAN

Homoeopathic Doctor Tariq Khan stated that presently world-class Homoeopathic Courses are running for Doctors (MBBS), Pharmacists (Pharm-D), Dentists (BDS) and Veterinary Doctors (DVM) in their relevant institutes, colleges and faculties of various Universities after having affiliation from Faculty of Homoeopathy UK which is incorporated in the act of UK Parliament and teaching Homoeopathy for the last 175 years around the globe. He suggested adopting similar courses for Homoeopathic Doctor in the best interest of Homoeopathy and for up-gradation of Homoeopathic System of Medicine.
